## Chelsea native Joe Smith, legendary music executive

Joe Smith, the legendary music executive who headed three major labels over the course of a career that started at the dawn of the rock 'n' roll era, has died. Family members including Donnie Smith, his wife of 62 years, were at this side when he passed away on the morning of December 2. For decades he was the industry's "goto guy" for scores of record business-supported charity events at which he served as emcee and "roastmaster." Thanks to his quick wit and gregarious nature, his remarks were often the highlight of hundreds of industry functions.

A native of Chelsea MA, Smith was elected President of the Chelsea High School Class of 1945 before serving in Asia with the US Army Infantry. Thereafter, taking advantage of the GI bill, he received a BA from Yale University. Following his graduation from Yale in 1950 he pursued a career in broadcasting and transitioned from sports caster to disc jockey, spending thousands of hours on the air at WMEX and WVDA Boston, maintaining personal relationships with rock and roll stars whose records turned into hits.

His theme song, performed by The Valentines, was "We're Gonna Rock With Joe Smith."



## Intense meeting

## No consensus, infighting, in vote for new Council President

The City Council membership convened Monday night for an intense meeting to try to find consensus on who would become president of the Council next year – and they closed with a stalemate that left Councillor Leo Robinson, the dean of the Council, holding the gavel for the time being.

Both Council President Damali Vidot and Councilor Calvin Brown were vying for the position, but ended up only getting five votes each. That left Robinson as the swing vote, and with both not having supported him in the past, he voted 'Present.'

That, as it turned out, catapulted him into the Council President seat for the time being until the stalemate can be broken.

"If there isn't a president elected and we can't come to a decision, then the senior member will be acting president until a decision is made," said Vidot. "In this case, that's Leo Robinson. Leo would stay president until someone gets the votes."

It was clear from the beginning that the outcome wasn't going to be decided Monday night – as has been the custom for years and years prior to the Jan. 6 inauguration and officer vote.

There were two votes taken in succession, and both turned out the same

Those supporting Vidot

were Councilors Judith Garcia, Yamir Rodriguez, Enio Lopez, and Giovanni Recupero.

Those supporting Brown were Councilors Roy Avellaneda, Naomi Zabot, Melinda Vega Maldonado and Todd Taylor.

Robinson, of course, voted present.

Afterward, Vidot said she looks forward to continuing the process of choosing a leader.

"I am grateful to my colleagues for their belief in me by supporting my leadership on the City Council," she said. "Their decision to stand in solidarity with me speaks to our shared interests in continuing the work we've been able to accomplish these past couple of years. There is a shared excitement about building coalitions with the new members of the council to amplify the voice of the community at large at City Hall. I am looking forward to continue the process in selecting leadership for 2020 that's reflective of our shared values."

Robinson said he hasn't been pleased with the leadership on the Council in 2019, and he hopes that excitement for Chelsea can return with a new leader.

"I hope we can agree on moving the city forward," he said. "I think what we lost in all this about who is with whom and who is doing what, is two years ago everyone was talking about

## Todd Taylor isn't looking for party politics, but solutions to problems

Todd Taylor is no stranger to Chelsea and its City government and social circles, but due to his Republican party affiliation, he said, he has often presented suddenly as someone not representing Chelsea values when he puts his name on the local ballot.

That changed for the first time in November when he won the Prattville seat on the City Council, and made the cut the third time he has run. It wasn't an easy process this past election, and it wasn't in the past either. There were constant rumors about him being a Republican, and a libelous mean character assassination letter was distributed through his neighborhood during the previous election.

It has been a lot for him to take, personally, and he said he will prove to all of his naysayers that he is out to help solve problems with his voice on the Council and not bring destructive national politics into the Council Chambers.

"I got elected this time, and it's the third time I've run," he said. "There are a lot of people that did all they could to try to keep me out. There are people who are skeptical - and that's putting it nicely - of me. I want to make it clear to people. I'm a problem solver. I'm somebody who just wants to help solve problems. I' not coming up here to be Mr. Republican. I do have a Conservative perspective, which could be refreshing, but I care about every single area of society. I had people on Bur-

ma Road supporting me. I had a lot of Latino people supporting me and a lot of support in the black community. It's the people who don't know me personally that are afraid. They don't need to be because I'm here to help the Council be more proactive."

Taylor is married to his wife, Regina, and lives in Prattville with his two children, Alana and Finn – both of whom go to the Edward Brooke Charter School in Eastie. He owns KSM Hospitality Staffing. He is getting ready to become the president of the Rotary Club in June, and has been on the Planning Board for

five years now. That service on the Plan-

ning Board is going to real-See TAYLOR Page 4

watch?v=oemdeObkogY He moved to Los Angeles in 1961 where he joined Warner Bros. Records as National Promotion Manager. He became the company's President in 1972 and worked with a stellar roster of artists including Peter, Paul & Mary, Rod Stewart, James Taylor, Alan Sherman, The Grateful Dead, Don Rickles, Van Morrison, Alice Cooper, Bonnie Raitt, Black Sabbath, Deep Purple, Petula Clark, The Doobie Brothers and Little Feat.

At Warner Bros., he produced The 2013 Year Old Man, the 1973 sequel to The 2000 Year Old Man album by Mel Brooks and Carl Reiner.

He moved over to Elektra/Asylum Records in 1975 as Chairman. The roster of artists there included Eagles, Linda Ronstadt, Jackson Browne, Queen, The Cars, Carly Simon, Judy Collins, Joni Mitchell, Grover Washington Jr., Mötley Crüe, X, and Hank Williams Jr.

In 1983, he was named President and CEO of Home Sports Entertainment, a division of Warner Cable. Following this, he became the first full-time President of the National Academy of Recording

Arts and Sciences. During this time, he appeared in motion pictures FM and One Trick Pony. He came back to the music industry on a full-time basis in 1987 as President and CEO of Capitol-EMl Music. During his tenure there, the company registered record profits from such artists as Garth Brooks, Tina Turner, Bonnie Raitt, MC Hammer, Bob Seger, David Bowie, Poison, and others. While

at Captiol, he oversaw the revitalization of the Blue Note label. Joe Smith's star on the Hollywood Walk of Fame is located in front of the Capitol Records Tower on Vine Street; both Bonnie Raitt and Jackson Browne spoke at his induction ceremony.

Keenly aware of the music industry's role in 20th century American culture, he sought to document the recollections of many of its key creative players in "Off The Record." Smith's book is based on interviews conducted with more than 230 artists, producers, managers and executives including Ray Charles, Paul McCartney, Artie Shaw, Ella Fitzgerald, Barbra Streisand, Bob Dylan, James Taylor, David Bowie, Stan Getz, Tony Bennett, Van Morrison and Dick Clark, Those audio interviews were donated to the American people in 2012 and now comprise The Joe Smith Collection at

the Library of Congress. www.loc.gov/collections/joe-smith

Upon his retirement from Capitol-EMI at the end of 1993, Smith assumed Executive Producer responsibilities to the World Cup Soccer tournament, where he was hired as executive producer of entertainment for World Cup USA in 1994, the first time the world's soccer championship was held in the United States. The tournament was crowned with a Dodger Stadium appearance by The Three Tenors that Smith fa-

Joe Smith is survived by his son Jeff Smith, daughter-in-law Amy Jo Smith and grandchild Lila Smith as well as daughter Julie Kellner, son-in-law Jamie Kellner and grandchild Christopher Kellner.

Joe Smith was inducted into both the Doo Wop Philadelphia Music Halls of Fame and received the Boston Music Lifetime Achievement Award. He was recipient of Billboard's Clive Davis Visionary Award and has been honored by the City of Hope and B'nai Brith and was granted an honorary doctorate from Berklee College of

Music. He served as Vice President of the Country Music Association, President of the Record Industry for Community Relations and as a board member of the Recording Industry Association of America as well as the Black Music Association. He has served as an officer or director of the City of Hope, Cedars-Sinai Hospital, TJ Martell Foundation, Variety Club and the Neil Bogart Memorial Lab. He served as a Trustee of the California Institute of the Arts, Yale School of Music, the Basketball Hall of Fame, Magic Johnson Foundation, Rhythm and Blues Foundation and the Museum of Science and Industry.

## 2019 holiday package delivery advisory

With the 2019 holiday season here, the Chelsea Police Department is once again reminding all residents to be aware of package theft as a result of internet shopping. The department wants you to take some common-sense steps so you do not become a victim of the Holiday Grinch.

The police department is taking a number of steps to prevent package thefts during the holiday season: uniformed and plainclothes officers have received training in the method of operation of package thieves. Officers are also made aware that thieves typically see UPS or Fed Ex trucks delivering packages as good opportunities to follow them to their delivery points and steal the items left behind. The following tips may prevent residents from becoming victims this holiday

- Request a drop-off time and date when you will be home; use a tracking number to follow your packages; request that the courier leave packages at the side or rear doors away from open view or with a neighbor who is home;. You may also request that your package delivery require a recipient signature.

- If you have a home security system, the department recommends you 'prominently display your home security system decals and signage," and set electronic alerts to receive notifications when the system detects activity around your delivery zone.

- Utilize email or text notifications regarding the status of your delivery, and consider purchasing a locking parcel delivery box that can be bolted down or otherwise secured.

vote of the night, with Vega Maldonado getting that spot in a 10-0 tally.

In the seating order, there was one interesting wrinkle in that Brown will sit next to Garcia - with Brown being the lone vote Monday against Garcia becoming vice president.

#### ARREST IN **SHOOTING**

On Dec. 2, at 4:48 p.m., officers were dispatched to a shooting in front of 12 Essex St. Officers and detectives developed information that led to an execution of a search warrant at 61 Shurtleff St. A male party was placed under arrest for his involvement in the shooting.

Edgar Nerys, 24, of 61 Shurtleff St., was charged with discharging a firearm within 500' of a dwelling, assault with a dangerous weapon, carrying a loaded firearm without a license, and possession of ammo without a permit.

Later, on Dec. 5, Santos Canizalez, 19, of 155 Pearl St., was arrested and charged with carrying a loaded firearm without a permit, possession of

ammo without a permit, assault and battery with a firearm, and discharging a firearm within 500' of a building.

#### FIREARM ARREST

On Dec. 4, at 7:11 p.m., officers were dispatched to Bellingham Square for a report of a male party threatening a female, and in possession of a firearm. While responding to the area, officers were informed that an off-duty officer, who was in uniform, was in foot pursuit of the male suspect. That officer was able to track the male into a market at 369 Broadway. The male was placed under arrest and a firearm was seized.

#### BANK ROBBER ARRESTED

ly affect how he approach-

es his Council seat. One big piece of his platform is home ownership, a major issue that surfaced last year at the Board and in the November election. While affordable housing rentals have been the norm in Chelsea, many residents and elected officials are pushing for increased market-rate and affordable home ownership opportu-

nities in the city. Count Taylor as one of them, and he believes that his approach can help stabilize the community and keep people from being displaced.

"We need to decide that more home ownership is a key," he said. "That doesn't just mean people coming in. It means trying to get people already living in Chelsea to graduate from being renters to being owners. My whole political

philosophy is the American Dream should be for people to be upwardly mobile no matter where you start. There are a lot of people afraid of gentrification, but if we're careful and thoughtful about how we do things, we can help people who feel the housing crunch and try to help them stay in Chelsea.'

He cited that mortgage rates are very low now, and if one can secure a mortgage, it is often cheaper than rent. However, he said people do need to understand that politicians cannot stop the forces of the market completely.

"It is important for people to understand politicians don't have a magic wand," he said. "It's like trying to stop the tide. There are forces that work in the markets...The City Council by sheer will cannot change the course

of where people move or don't move. It's not a dictatorship and you can't tell people what they can get for their property. We can only mitigate where people are getting squeezed."

There are also smaller issues within his district such as getting to the bottom of the turning lane on Washington Avenue at the Parkway. There are issues of traffic and also about parking.

He said when going door to door last summer in District 1, there were very few people in the Prattville area that didn't list parking as a key issue. That, he said, is because many people from the CHA Everett hospital or commuters park long-term in District 1.

"There's no reason we shouldn't have residential

parking only in District 1," he said, "at least to preclude people from parking in the neighborhood who don't live or work here. Parking is the top priority

in District 1." Beyond all of the issues, and the philosophies of government, Taylor said he feels his first few months will be about proving him-

"I guess I'll have something to prove to people,' he said. "I'm not doing this for the money or because it's easy. It's not. I'm doing this because I love Chelsea and I want to see it move in a more positive direction for everyone."

Taylor will take the seat officially for District 1 during the Jan. 6, 2020 inauguration ceremony in City Hall.

#### Excel Academy DESE Tiered Focused Monitoring 2019

During the week of January 6th the Department of Elementary and Secondary Education's Office of Public School Monitoring (PSM) will conduct a Tiered Focused Monitoring Review of Excel Academy Charter Schools. The Office of Public School Monitoring visits each district and charter school every three years to monitor compliance with federal and state special education and civil rights regulations. Areas of review related to special education include student assessments, determination of eligibility, the Individualized Education Program (IEP) Team process, and IEP development and implementation. Areas of review related to civil rights include bullying, student discipline, physical restraint, and equal access to school programs for all students.

In addition to the onsite visit, parent outreach is an important part of the review process. The review chairperson from the Office of Public School Monitoring will send all parents of students with disabilities an online survey that focuses on key areas of their child's special education program. Survey results will contribute to the development of a report. During the onsite review, the Office of Public School Monitoring will interview the chairperson(s) of the district's Special Education Parent Advisory Council (SEPAC). Other onsite activities may include interviews of district staff and administrators, reviews of student records, and onsite observations. Parents and other individuals may call Moses Nduati, Public School Monitoring Chairperson, at (781) 338-3707 to request a telephone interview. If an individual requires an accommodation, such as translation, to participate in an interview, the Department will make the necessary arrangements.

Within approximately 60 business days after the onsite visit, the review chairperson will provide the Excel Academy Charter Schools with a report with information about areas in which the Excel Academy Charter Schools meets or exceeds regulatory requirements and areas in which the Excel Academy Charter Schools requires assistance to correct or improve practices. 




## John Roger Green


