Interviews start for city manager staff positions

In his first weeks in office, new City Manager Fidel Maltez has been working to fill out his staff.

Late last year, the city council approved a request from Maltez to fund a reorganization of the city manager's office that sees staff increase from three to five employees.

Rather than one deputy city manager, the office will now operate with two deputy managers reporting to Maltez, one for operations and one for finance. In addition, the council also approved funding the new position of Director of Constituent Services.

The duties of that position include listening to resident concerns, providing information and assistance, coordinating with the city council, and advocating for residents,

City looks to increase lead testing

Chelsea health officials are looking to increase lead testing in the city and get back to its pre-pandemic testing rates.

The majority of Chelsea properties were built before 1970, and environmental factors put the city's children at risk of lead poisoning. Lead is harmful to human health, and in children, lead exposure can cause life-long health effects, including problems with learning and development.

A screening blood test is the only tool available to identify lead exposure in children. months to 5 years. Medical providers are sending notifications to children who have fallen behind their annual lead test.

To all parents and legal guardians:

• If you are informed that your child is due for a lead test, get your child tested as soon as possible at their doctor's office.

• If you believe your child needs to be tested, please follow up with your child's doctor or medical provider.

• If your child is upto-date with their annual lead test, no action is required, and you may discuss it with the provider at the next annual wellness check.

Toro netted three 3-pointers from beyond the NBA 3-point line on his way to a team-high 15 points in the 67-53 loss to the Falcons.

"Justin hit some big three-pointers for us from NBA range," said CHS head coach Cesar Castro. "I give him the ultimate green light to shoot the basketball. He just started playing basketball in the eighth grade, but he has tremendous confidence in his abilities."

"Christine Baldini's qualifications and dedication to high-quality senior living care made her the ideal candidate," said Secretary Jon Santiago. "I'm thankful for Robert Engell's leadership during this transition marked by several milestones, and I'm confident that Christine's leadership will add to the momentum while creating an environment that fosters opportunity, growth, and worldclass excellence in longterm care."

"I am honored to join Chelsea Veterans the Home as the Superintendent," expressed Christine Baldini. "My goal is to continue the legacy of exceptional care and support for our veterans, building on the foundation of excellence established by the Executive Office of Veterans Services. My career has been dedicated to ensuring the well-being of those under my care, and I am eager to continue this mission with the veterans at Chelsea."

The newly constructed Veterans Home at Chelsea, a state-of-the-art building with 154 private resident rooms, is designed with a strong focus on energy efficiency.

In October, the Massachusetts Executive Office of Veterans Services proudly announced that the Veterans Home at Chelsea (CHE) secured the Department of Public Health (DPH) Licensure and the Centers for Medicare and Medicaid Services (CMS) Certification, officially designating it as a skilled nursing facility.

These critical licensures facilitated the relocation of the initial 20 residents into the new veterans home. Soon after, the Veterans Home underwent and passed its initial State Veterans Home recognition survey by the US Department of Veterans Affairs. The VA Rec-

according to Maltez.

Maltez said the search to fill those positions is going well.

"Chelsea is an exciting community, and I am very excited about the number of applicants that we received and the caliber of the applicants," he said. "Chelsea is a gateway community, we are always in conversations with Boston, with Somerville, with Cambridge. For anyone who wants to do good work, Chelsea is a good place to be."

The interview process is ongoing now, and Mal-

tez said he'd like to make a decision on final hires by the end of January.

"They are critical to the long-term operation of the city," said Maltez, especially as the municipal budgeting process for the next fiscal year kicks off in City Hall.

In addition to the positions in the city manager's office, the city is also looking for a new Director of Housing and Community Development to replace Alex Train, who left that position at the end of last year.

"I wish (Train) nothing

but the best," said Maltez. "He was a huge asset for the city of Chelsea and really accomplished a lot. He brought in a lot of grants to the city, he created a lot of innovative and progressive projects and programs that really benefited our residents."

Four local organizations award grants through state CERP

Four Chelsea nonprofits were among the 67 organizations across Massachusetts who were awarded a state Community Empowerment and Reinvestment Program (CERP) grant last week.

CERP is a competitive grant program that offers flexible operating grants to local collaborations for programming and projects that develop, strengthen, and invest in community economic priorities. The program aims to bring positive economic outcomes to communities that have been adversely impacted by the criminal justice system and poverty.

Governor Maura Healey stated that more than \$15 million in grants was awarded to the 67 organizations. In Chelsea, the organizations that benefited from the grants included CAPIC, La Colaborativa, The Neighborhood Developers, and HarborCOV.

"Our administration is committed to making Massachusetts a state where everyone has access to economic opportunity," said Healey. "The Community Empowerment and Reinvestment Program is reshaping our communities by providing resources for programs that strengthen our communities through job training, small business support, housing stability, and more. We congratulate the awardees on this hardearned achievement and thank the Legislature for

their partnership to make this funding available."

CAPIC received \$100,000 for a project that will link individuals who have been impacted by the criminal justice system to care and recovery support from a variety of settings to improve access to programs and resources that address trauma and other risk factors for substance and alcohol use. Specifically, CAPIC will further expand upon current partnerships with the SELAH Day Resource Center and the Chelsea Police Department.

CAPIC will provide comprehensive case management; recovery coach support, mental health services/counseling, access to community healthcare, transportation, gift cards to purchase food, crisis intervention support, and access to transitional housing and sober living.

HarborCOV received \$165,000 to provide survivor-centered case management, housing support, and legal representation to domestic violence survivors who are experiencing or at-risk of homelessness. These survivors are often impacted by disproportionate barriers to stable housing due to their experience of abuse, past criminal justice involvement, employment and workforce challenges, housing discrimination, and vulnerable immigration status. HarborCOV staff will partner with survivors to outline a plan to overcome these barriers to housing and meet their needs and goals for stability.

La Colaborativa received \$400,000 for Chelsea Youth Work, which is designed to jumpstart economic mobility and deliver just and equitable access to critical employment training for Chelsea's most vulnerable youth. This project will allow youth to avoid involvement with the juvenile justice system, overcome structural barriers and build wealth and wellbeing for generations to come.

The Neighborhood Developers received \$225,000 for the CON-NECT Hotline to facilitate access to pandemic relief funds. The Hotline, now a permanent fixture, continues to provide oneon-one support to callers facing housing instability and other economic challenges.

Lt. Governor Kim Driscoll said CERP plays a vital role in supporting communities that face significant barriers to economic growth in the state.

"This funding will provide assistance to organizations that are doing critical work to improve public health, support small and diverse businesses, engage with young people, provide education and workforce opportunities and so much more," Driscoll said. "This program will help strengthen our bond with local leaders to safeguard the well-being of all residents."

MA Department of Public Utilities approves city's electricity aggregation program

The city recently received approval from the Massachusetts Department of Public Utilities (DPU) for its electricity aggregation program, Chelsea Electricity Choice.

Eversource's prices change seasonally and their future prices are unknown, Chelsea Electricity choice cannot guarantee to provide savings.

Residents' electricity accounts will be eligible for automatic enrollment

Residents will still be getting one bill from Eversource if they take part in the program, and Eversource will still be responsible for handling all electrical issues in the city, Maltez said.

The city anticipates launching the program later this year, according to City Manager Fidel Maltez.

Chelsea Electricity Choice is a group electricity buying program from the City of Chelsea for residents and businesses. The program will provide electricity customers in Chelsea with a transparent, trustworthy alternative to private electricity offers.

Through the program, Chelsea will sign longterm fixed-price contracts that will prioritize the purchase of electricity from renewable sources like wind and solar. By offering long-term prices, Chelsea Electricity Choice will keep electricity prices stable and can provide protection from high winter price increases, according to Maltez.

In addition, Chelsea Electricity Choice has the potential to provide savings compared with Eversource's Basic Service prices. However, because in Chelsea Electricity Choice if they have not already signed a private contract with an electricity supplier (such as Eversource's Basic Service). Those that have signed a private electricity supply contract, you will not be automatically enrolled, but you can choose to enroll with a phone call or online. Participation is never required, and residents may leave Chelsea Electricity Choice at any time with no

fee or penalty. "It's something that a lot of communities are taking advantage of," said Maltez. "What we are able to do, is we are able to buy electricity for all of our residents in bulk. By us buying our own electricity we are able to lock in rates longer so we don't have to go by the fluctuation of Eversource, and we are able to protect residents from third-party energy contracts, which can be predatory.

They are not necessarily all predatory, but they can be."

step is for the City to sign an electricity supply contract. Once that contract is signed, the city will conduct an outreach effort before the program launches, and will be able to share program prices, the launch date, and information about how to enroll or prevent enrollment. As part of that outreach, the city will conduct public information sessions and will notify by mail anyone who is eligible for automatic enrollment.

"Since it was first approved, basically in my first week here, I am working really hard to make sure it gets rolled out efficiently and that residents see the benefits sooner rather than later," said Maltez. "I know that residents in Chelsea in particular are very utility burdened. A lot of their income goes to utilities, so any kind of reduction in electricity cost is going to help all the residents."

PUBLIC NOTICE **RIGHT OF WAY MAINTENANCE**

As required by Massachusetts General Law Chapter 132B, National Grid (New England Power and/or Massachusetts Electric Company) hereby gives notice that it intends to selectively apply herbicides along specific transmission line rights-of-way in 2024.

The selective use of herbicides to manage vegetation along rights-of-way is done within the context of an Integrated Vegetation Management (IVM) program consisting of mechanical, chemical, natural, and cultural components. In right-of-way vegetation management the pest or target is vegetation (primarily tall growing) that will cause outages and safety issues. National Grid's IVM program encourages natural controls by promoting low growing plant communities that resist invasion by target vegetation. The selective use of herbicides and mechanical controls are the direct techniques used to control target vegetation and help establish and maintain natural controls.

National Grid may utilize any of the herbicides noted the MA Sensitive Materials list. Rodeo, and possibly one of the following herbicides, Arsenal or Arsenal Powerline, will be applied directly to the surface of stumps immediately after target vegetation is cut (Cut Stump Treatment). Garlon 4 or Garlon 4 Ultra will be applied selectively to the stems of target vegetation using hand-held equipment (Basal Treatment and Dormant stem treatment). Krenite S or Rodeo, mixed with Escort XP, and one of the following herbicides, Arsenal or Arsenal Powerline, or Milestone will be applied selectively to the foliage of target vegetation using hand-held equipment (Foliar Treatment). Cambistat as a tree growth regulator. Applications shall not commence more than ten days before nor conclude more than ten days after the following treatment periods. "TO THE SHORES OF TRIPOLI..."

The ongoing attacks against international shipping in the Red Sea by the former terrorist organization known as the Houthis, who presently are the ruling group in Yemen, are "illegal, unacceptable, and profoundly destabilizing," in the words of the dozen nations who coalesced with the United States to launch a series of attacks against Houthi missile sites in Yemen last week.

The Houthis, who also have fired long-range rockets toward Israel and U.S. naval forces in the Red Sea, assert that their actions are in support of Hamas, the terrorists responsible for the slaughter, rape, and kidnapping of more than 1400 Israeli citizens on October 7.

Clearly, the Houthi attacks are part of an overall strategy by Iran, which has supplied weapons and funds for decades to the Houthis, Hamas, and Hezbollah, to cause as much death and destruction to Israel and its allies, with the stated goal of wiping Israel off the face of the map and killing every Jew they can find.

Some, both here and abroad, have criticized the United States and its allies for bombing the Houthi missile sites because it might lead to a widening of the ongoing war in the Middle East and draw the United States into the middle of the fight.

However, critics of U.S. policy are deluding themselves if they think that America somehow can remain above the fray, especially now that the Houthis are threatening the free flow of global commerce. U.S. history is instructive in this regard. In the 18th and early 19th centuries, what was then known as the Barbary coast nations of the Mediterranean -- present-day Morocco, Libya, Algeria, and Tunis -- plundered international shipping and enslaved thousands of their captives, including U.S. ships and citizens.

The United States Navy was established to respond to the blatant acts of nation-state piracy, culminating with an attack by the U.S. Marines, who burned the city of Tripoli in 1805 -- hence the phrase in the opening line of the Marine Corps anthem, "From the halls of Montezuma to the shores of Tripoli."

We realize that the circumstances between 1805 and today are vastly different, but the principle remains the same. More significantly, we must recognize that the world is being destabilized by an Axis of Evil consisting of Iran, Russia, and China. We cannot afford to bury our heads in the sand and pretend that they do not pose a threat to the Free World.

We must deal with the Houthis and their terrorist brethren to the full extent that we are able to do so. Anything less only will encourage them to go further.

DiDomeni-Senator co and his colleagues in the Massachusetts Senate voted unanimously to strengthen consumer protections for wheelchair users.

Act expanding An wheelchair warranty protections for consumers with disabilities-S.2541-requires all wheelchairs to come with warranties, extends the minimum warranty period to two years, sets standards for wheelchair repairs and replacements, and eliminates the cumbersome prior authorization process for all wheelchair repairs under \$1,000.

"I was proud to take action on this critical legislation in order to protect and empower wheelchair users throughout our state," said Senator Sal DiDomenico, Assistant Majority Leader of the Massachusetts Senate. "Passing this bill puts us one step closer to supporting the countless Massachusetts residents who rely on wheelchairs and have suffered with unaffordable wheelchair repairs for far too long. I want to thank Senate President Karen Spilka, and Senator John Cronin for focusing on this important and neglected issue."

DiDomenico, Senate pass wheelchair warranty reform

The legislation requires all wheelchairs sold or leased in the Commonwealth to come with express warranties-a change from the current law, which only requires customized wheelchairs to come with express warranties. The legislation also extends express warranties for wheelchairs from one year to two years, bringing Massachusetts in line with states like Rhode Island and Connecticut. To alleviate wait times for repairs, the bill mandates that wheelchair service providers diagnose repair issues remotely within three business days following notice from a consumer and provide an in-person assessment no more than four business days after that.

If a wheelchair user cannot operate their in-warranty chair during the repair process, the bill mandates that manufacturers or dealers reimburse them for or provide a loaner wheelchair within four business days for most wheelchairs, or within eight business days for

highly customized wheelchairs.

The bill also requires manufacturers and dealers to cover any collateral costs incurred during the repair process for in-warranty wheelchairs. For out-of-warranty wheelchairs, the legislation prohibits insurers for requiring consumers to go through a cumbersome prior authorization process for any repairs totaling less than \$1,000. Finally, the bill allows the Attorney General's office to take legal action against service providers who violate these provisions with unfair or deceptive business practices.

The legislation has received strong support from disability advocates across Massachusetts.

"S.2541 reflects an understanding of the challenges faced by wheelchair users and sets a new standard for consumer protection that will improve the quality of life for wheelchair users across Commonwealth," the Barbara L'Italien, said Executive Director of the Disability Law Center. "We are grateful to Senate President Spilka,

Senator Cronin, and the Massachusetts Senate for recognizing the profound impact this legislation will have on individuals with disabilities who utilize wheelchairs."

"When a wheelchair, providing mobility so people can integrate into the community, too often breaks down, with waits as long as a year for repairs-we can fix cars and bikes in a day! -we have a serious problem," Kay Schoucair, Senior Organizer, Boston Center for Independent Living (BCIL). "The time is overdue for manufacturers to simply stand behind their products. BCIL applauds the senate for pushing this much needed bill forward."

A similar version of the legislation was passed by the Senate in 2022, however that legislation did not further advance in the Legislature.

Having been passed by the Senate, the legislation now heads to the Massachusetts House of Representatives for consideration.

WITH NO. KOREA NOW INVOLVED, AID TO UKRAINE **IS NEEDED ASAP**





CHS GIRLS TRACK EDGES SOMERVILLE

The Chelsea High girls indoor track and field team competed in a trimeet with Greater Boston League (GBL) foes Somerville and Medford last week at the Reggie Lewis Track and Athletic Center, narrowly edging the former, but falling just short to the latter by a single point.

The contest with Medford, which was decided by literally just hundreths of a second, saw Chelsea fall short by a score of 46-45.

The first-place winners for the Lady Red Devils vs. the Lady Mustangs were: Rosalinda Rojas in the 600 dash with a tme of 2:01.19; Jada Amezquita in the 1000 with a clocking iof 4:07.16; Thania Simon in the long jump with a leap of 14'-5"25; Kiara Ramirez in the shot-put with a throw of 30'-4"; and Giselle Olivar in the

55 hurdles in a time of 9.89.

The outcome of the Medford meet was decided in the two relay events (the 4 x 400 and 4 x 200) in which the two Lady Mustang quartets prevailed, winning the 4 x 200 by a margin of just 2.09 seconds.

An even-closer competition came in the 55 meter dash in which Chelsea star freshman Thania Simon (who was Chelsea's top scorer on the day with a total of 17.25 points) took second-place to the top Medford girl by the slim margin of just 0.05 of a second.

In the Somerville portion of the tri-meet, the Lady Red Devils nipped the Lady Highlanders, 50-46. Somerville captured all of the dash events, other than the 55 hurdles, but Chelsea excelled in the distance and field events: Gizelle Rodriguez winning the mile in a time of 6:32.08; Simon leading a Chelsea sweep in the long

jump; Ramirez leading a Lady Red Devil sweep in the shot-put; and Olivar taking the hurdles.

In addition, the Chelsea quartet of Keiri Hernandez, Meleny Rodriguez, Marcayll Louis-Jean, and Simon won the 4 x 200 relay to seal the victory.

"In the end, the girls were able to get a win vs Somerville, and just narrowly lost to Medford by one point," said CHS head coach Cesar Hernandez. "We knew both meets could go either way, but overall the girls had a great meet."



Following in just about a week later, the National Hockey League announced that Boston Bruins goaltender Jeremy Swayman had been selected for the 2024 NHL All-Star Game. 

Local business owner sentenced in mail fraud scheme

Staff Report

The former owner and operator of APC, a transportation and delivery company based in Chelsea, was sentenced on Tuesday for his involvement in a mail fraud scheme.

Anthony Catalano, 52, formerly of Boxford, now living in Winthrop, was sentenced by Chief United States District Court Judge F. Dennis Saylor IV to six months in prison, followed by three years of supervised release and restitution in the amount of \$541,000 to The Travelers Insurance Company (Travelers). Catalano was also ordered to cooperate

with the Internal Revenue Service regarding personal and corporate taxes due and owing.

Catalano pleaded guilty in October 2023 to two counts of failing to collect, report and pay over employment taxes and one count of mail fraud in connection with cash wages he paid to company employees.

From 2017 to 2020, Catalano cashed more than \$8 million in APC checks from customers and failed to report the company income to the IRS. Catalano pleaded guilty to using the bulk of the cash funds to pay employees "under-the-table"

cash wages which APC was also required to report to the IRS.

As a result, neither the company nor the employees paid employment or income taxes on the cash wages, resulting in a tax loss of more than \$1 million to the IRS. Catalano also pleaded guilty to mail fraud for failing to disclose the cash wages to Travelers when it provided workers' compensation coverage for APC employees. As a result, Catalano defrauded the insurance carrier out of more than \$500,000 in insurance premiums, according to the U.S. Attorney's Office.

A dog for all seasons

City Paws

Some dogs enjoy our changeable New England weather. They are adaptable and happy to go out and explore as long as they are with you. Others are happier basking in the warm sun on a beach or frolicking in the snow in winter.

Did you ever consider that your relationship with weather conditions should influence your choice of dog? If you hate the cold, ice, and snow, a high-energy dog who needs a lot of exercise any time of the year might be difficult. On the other hand, if you love the summer and want to take long dog walks on sunny days, a flat-faced dog like a Bulldog might have breathing problems trying to keep up with you.

Origins Make a Difference

The seasonality of a dog depends, in part, on genetics and breeding. A dog's body, tail, coat, and personality depend on the work humans refined the breed to perform. Among the best examples of this are sled dogs. A clue to the weather adaptation of the Alaskan Malamute and Siberian Husky is in their name and their work. They originated in cold places to pull sleds.

The American Kennel Club (AKC) points out the necessary qualities of a sled dog. "One of the most important is good feet. Long-distance races are tough on a dog's body, and the feet bear the brunt of the work." AKC continues, "A healthy appetite and a thick coat are also important. Picky eaters might not take in the

necessary calories on the trail, which reduces their performance ability. A healthy coat with a thick undercoat helps keep a dog warm and protected from the elements and preserves those essential calories."

However, while genes are one factor, within breeds, you'll find dogs who adapt to seasons in far different ways. Our first Westie, Sassy, loved basking in the sun. Number two, Maggie Mae, adapted to any season as long as she could be outside socializing, whereas Poppy loves playing in the snow.

Adaptations Can Help

We can help a dog adapt to our seasonal conditions. In winter, if you have a short-haired dog who needs a lot of exercise, like a greyhound, you must protect her from the cold and wet. Friends with a former racing dog use a layered coat system for winter walks. It has a thin layer for cool days, a thicker layer with a snood to keep her ears and neck warm on cold days, and a rain jacket that fits over either or both for wet days. Aside from adaptive

clothing, you can vary the time of your exercise walks. Take that husky out anytime in winter but in the coolest hours in summer.

Age and Health

Other adaptations are for age and health. You may have specific exercise directions from your veterinarian for a dog with a specific medical condition. Ask about this on your next vet visit, especially if you and your dog have moved here from an area with very different weather.

Carriers and strollers can make longer walks possible for dogs with injuries, health conditions, and as they age. Years ago, friends with an aging Airdale bought her a little red wagon to transport her to a favorite park. Recently, we spotted a gentleman pushing his Bulldog in a low-to-ground stroller. It enabled the big boy to step in and out by himself, a perfect adaptation for both the dog and the guardian.
