## Police department gets \$55,000 municipal safety grant

Healey-Driscoll The Administration recently awarded more than \$12.4 million in federal traffic safety funding to promote safer roads in communities across Massachusetts, including \$55,000 for Chelsea through the Municipal Road Safety Program.

The funds are managed and administered in Masof Grants and Research (OGR).

"Everyone deserves to

be safe on Massachusetts streets, whether traveling by car, foot, public transportation or bike," said Governor Maura Healey. "As individual communities work to address their unique traffic safety concerns, these programs pro-

sachusetts by the Office vide resources and supports that will ensure they have the tools they need to protect road users."

Funds awarded to municipal police departments through the Municipal Road Safety Grant Program allows the departments to afford initiatives that include conducting traffic safety enforcement, bicyclist and pedestri-

an safety enforcement, non-enforcement activities such as trainings or community events, and purchasing traffic safety equipment or safety items to distribute in the community such as bike helmets. This year, OGR awarded \$5,637,336.83 to 191 departments – a record number of recipients

for the program.

## Planning board approves site plan for battery storage facility

The planning board approved the site plan for the Flatiron Energy Energizer Storage battery storage facility proposed for 284 Eastern Ave. at its regular meeting last week.

In addition, the board recommended approval of a special permit and variances for the project when it comes before the zoning board of appeals on Tuesday, Oct. 8.

Flatiron Energy is an energy developer, owner, and operator that owns and operates the energy storage systems it develops. Flatiron is looking to finalize the purchase of the Eastern Avenue property in early December, according to Flatiron co-founder and partner Jonathan Poor.

The company has offices in Boston, New York City, and Boulder, Colorado and is currently developing energy storage systems in the Greater Boston, Connecticut, and New York City areas.

The project was originally before the planning board in May to review the plans for the construction of the battery energy storage structure on Eastern Avenue.

The property itself is

## NeighborHealth announces major clinical care expansion to meet community need for primary care

NeighborHealth, merly East Boston Neighborhood Health Center, announced a multi-faceted clinical space expansion at the community health system's 20 Maverick Square outpatient facility adjacent to MBTA's Maverick Station in East Boston. This multi-year, two-part construction project is part of NeighborHealth's ongoing efforts to extend access to healthcare and social services across Greater Boston in response to the Commonwealth's ongoing healthcare capacity chal-

The multi-year initiative will add 27,000 sq. feet of clinical space and 60 additional exam rooms to NeighborHealth's existing East Boston footprint, enabling the health system to accommodate thousands of new primary care patients over the next decade. Conversion of 20 Maverick's existing 4th floor into clinic space is now in progress.

"There simply isn't enough access to primary care in Boston, and it's a challenge that we're committed to addressing," said Greg Wilmot, President and CEO at NeighborHealth "This project will help connect more of our neighbors to the high-quality primary care they need and deserve."

specifical-Designed ly with patient-centered, team-based care in mind, the new fourth floor also supports interdisciplinary collaboration.

"Not only is Neighbor-Health investing in more clinical space; we are also

investing in our care model which brings a diverse team of medical professionals to fully respond to complex and nuanced needs of today's patients," said Dr. Julio Mazul, Vice President and Interim Chief Medical Officer at NeighborHealth. "By working as a team, we are able to care for many more patients across our communities than a traditional primary care practice would be able to."

In addition to innovative design, NeighborHealth is trailblazing socially responsible and sustainable building practices. In an unprecedented commitment, Neighbor-Health is exceeding existing minority participation benchmarks for its construction workforce, requiring that 50% of direct worker hours be fulfilled by minority workers and 40% of total construction funds be paid to minority-owned businesses. Together, these practices set the highest minority participation goals of any construction project within the City of Boston.

"We are truly pushing boundaries when it comes to how we build this space," said Dr. Ryan Boxill, Executive Vice President and Chief Operating Officer. "This project is an investment in the community, and we are setting a new standard in our city, both in terms of our requirements for diversified onsite labor and total project dollars spent on contractor-owned businesses of color."

The multi-year project will take place in two distinct phases, commencing

• Phase I: Fourth Floor Clinical Space Conversion

The first phase of the project includes the renovation of the existing fourth floor, previously used for administrative offices, into clinical space for Adult Medicine, NeighborHealth's fastest growing department. The renovation, which began in July 2024, is scheduled for completion in spring 2025 and will host 18 new exam rooms. The project is funded through a combination of federal and state grants, with an estimated budget of \$5.5 million.

• Phase II: Three-Story Addition

The second phase of this project envisions the construction of a three-story addition over the existing parking lot on Paris Street, adding approximately 17,262 square feet to the existing 49,000 square-foot 20 Maverick Square outpatient facility. The proposed design will match the existing building's height and setback, featuring a glazed exterior that compliments East Boston's historical architecture and inspires innovation within the community. Construction will begin in 2025/2026 based on ongoing funding.

Hamilton shared why she is walking. "I am joining hundreds of thousands of people across the country who are walking in the Out of the Darkness Community Walks to prevent suicide and support AF-SP's mission to save lives and bring hope to those affected by suicide. I walk in memory of Ashley Frawley, who took her own life on August 30, 2015. Since September of that year, we have been proud to walk alongside the American Foundation for Suicide Prevention. We discovered this organization just weeks after losing Ashley, and our mission has been clear: to raise awareness about suicide prevention and to break the stigma surrounding mental health. I also walk in memory of

Gabriel Salado, who took his own life on May 6. 2021. Gabe participated in many walks and fundraisers for suicide prevention, and his spirit continues to inspire us. We walk in memory of our dear friends, holding onto hope that by sharing their stories, we can help prevent further loss and create a supportive community.Together, we strive to ensure that no one feels alone in their struggle. ## **National PACE Month observed**

This September, organizations across the country came together to raise awareness of an important senior care program we are fortunate to have in our Greater Boston community - PACE - or Program for All Inclusive Care for the Elderly. PACE offers a unique care model designed to help older adults maintain healthy, independent, and active lives in their homes and communities. The program serves over 77,000 participants nationwide and is growing every day.

Begun in the 1970s in San Francisco's Chineighborhood, natown PACE is a model of care that has steadily grown since then, providing holistic and individualized care solutions that allow older adults to live at home with a higher quality of life and at a reduced cost compared with other healthcare settings such

as nursing homes. Care is provided by interdisciplinary teams comprised of primary care providers, registered nurses, home care coordinators, personal care attendants, dietitians, social workers, transportation drivers, PACE center managers, as well as physical, occupational and recreational therapists. In 1990, the East Bos-

ton Neighborhood Health Center, now Neighbor-Health, launched its PACE program, becoming a pioneer in Massachusetts by providing this unique medical services plan for seniors in East Boston and surrounding communities. Working hand in hand with families, these services provide an alternative to nursing home care.

Since then, the Neighborhood PACE program has expanded its services to improve the quality of life for adults over 55, operating five sites in East Boston, Winthrop, Everett, and Revere with both clinical care and social and wellbeing activities.

"The PACE program offers a wide variety of services, including primary and specialized medical care, prescribed medications, social services, rehabilitation, and more,' explained Revere resident Lidia Hernández, member experience manager for the Neighborhood PACE program.

Today, the program serves more than 850 seniors in East Boston, Revere, Winthrop and Everett, as well as Chelsea, Malden, Medford, Melrose, Stoneham, and the North End.

"We also provide transportation for medical appointments, manage medications, and even deliver food to the homes of those who cannot prepare it themselves," Hernández noted, emphasizing the importance of these services for seniors and their families.

Family members and caregivers also benefit from PACE. Lidia, shared story illustrating the program's impact: "We recently assisted an older woman whose family was struggling to take care of her at home. about 3.7 acres and includes Willoughby Street, which Poor said will be the main access point to the project.

The property is also adjacent to the Eversource Chelsea electrical substation. Poor said this means Flatiron will be able to use an underground connection to tie into the electrical grid.

The proposed building itself would be two stories and will have a number of compartment areas where the batteries will be stored. Outside the building will be energy inverters, transformers, and other infrastructure.

At last week's planning board meeting, Poor reviewed the activity Flatiron has taken since the initial meeting with the planning board in the

Poor said they have worked with their landscape architect and community partners such as GreenRoots to rework the landscaping plan for the

"We want to create as much green space as possible on the property,"

Poor side. In addition, he said

Flatiron is working to help mitigate urban heat islands in the area by installing a white roof to reflect sunlight on the building, and creating as much impervious area on the property as possible. Flatiron and its consul-

tants have also reviewed the findings of a consultant hired by the city for a peer review, as well as by the fire department, on the project's fire safety and hazard mitigation plans, Poor said.

"The feedback was relatively minimal, we are going to take that feedback and address it," he said, adding much of the feedback will be addressed by the time of the ZBA meeting.

Flatiron and the city have agreed to a PILOT (payment in lieu of taxes) agreement, and Poor said he expects a host community agreement for the project to come before the city council in the next few weeks.

Planning board members did question Poor about some of the fire and

safety measures that will be in place at the facility.

"We are designing our building's fire protection and detection systems to not only the most recent standards that are available, we are actually work with FRA (fire risk assessment) and those other groups to design our project to the upcoming standards that will be released either at the end of this year of the beginning of next year," said Poor.

He added that Flatiron is also working with its consultants and the fire chief on an emergency response plan.

Planning board member Mimi Rancatore said she would like to see some kind of additional design elements to make the building more attractive.

"I understand the landscaping is going to be helpful, but it would also be nice to have something else on the building," she

## City manager provides update on opioid settlement funds

Chelsea is slated to get approximately \$2 million from a total of seven opioid settlements through Fiscal year 2038.

At last week's city council meeting, City Manager Fidel Maltez provided an update on those funds and how the city plans to use

The office of the Massachusetts Attorney General and many other attorneys general from across the country settled lawsuits against opioid manufacturers, distributors, and retailers for their roles in contributing to the devastation caused by the opioid crisis, Maltez stated. The settlements provide that the defendants pay states and municipalities money annually through FY38 to supplement and strengthen resources for opioid prevention, harm reduction, treatment, and recovery.

To help plan for how to most effectively spend the Police department gets \$55,000 safety grant

funds the city is expected to receive, Maltez said the city held two planning sessions in the spring with invited stakeholders. The city also issued an open application for opioid community abatement funds.

"The overall guiding principle is to use the funds to save lives," stated Maltez. "In Chelsea, even acknowledging incomplete reporting, there were eight deaths and 133 overdoses in a 16-month period."

Over the next three fiscal years, Maltez said the city anticipates receiving and making available \$780,000 in the settlement Maltez noted that Chel-

sea is one of the few communities in the state that has operated a substance use disorder system for several years to address substance use with several ongoing projects. "Therefore, as a gener-

al matter, the Opioid program in Chelsea will build upon and expand existing prevention and intervention projects," Maltez.

After reviewing the applications for the opioid abatement funds, Maltez said the city made awards to three projects.

Roca will use the funds to provide lifesaving cognitive behavioral theory skills, as well as education and workforce readiness programming, employment, and effective referral and connection to harm reduction services and clinical care to young people with opioid and substance use disorders.

The CAPIC Opioid Project will connect individuals with substance use disorders to appropriate and equitable intervention in a coordinated way and to increase their quality of life and to lead a self-sus-

The Opioid Overdose Reporting Project will be a non-fatal drug overdose tracking and reporting sys-

taining life.

#### **BICYCLING IS NOT SAFE** IN GREATER BOSTON

The tragic death of a 62 year-old bicyclist last week on Memorial Drive has highlighted the lack of safety on our roadways for even experienced cyclists. We ourselves know first-hand how dangerous Metro Boston's roads can be. We train for triathlons and are fully aware that we are taking our life into our own hands whenever we take off for a ride. Even in places where there are bike lanes on the roads, those bike lanes always just end precipitously -- eventually forcing cyclists to navigate unsafe roads alongside high-speed automobile traffic.

And even when we are in a bike lane, we still have to deal with motorists who pull out halfway into the bike lane in order to see oncoming traffic, or who are distracted thanks to cell phones, or who are under the influence (either by alcohol or marijuana), or who are just bad drivers, not to mention the prospect of being "doored" by an inattentive driver exiting their parked car adjacent to the bike lane.

Although we applaud the trend toward encouraging bicycling both for exercise and in order to reduce our dependence on cars for environmental reasons (we used to commute to work on our bike on nice days and rode our bike routinely when we were in college in Cambridge), the reality is that bicycling never is going to be widely-adopted by commuters thanks to rain, snow, ice, and summer heat-and-humidity. It's a good way to get exercise, but it has its limitations for our increasingly-aging populations and for those who are not mobile.

Biking has its place in communities with designated bike paths, such as those on Cape Cod and the islands, where we enjoyed many bike rides with our children when they -- and we -- were younger.

But the reality of the push to get people on bicycles. as laudable as it may be, is that it only will lead to more tragedies on our unsafe roads. The National Highway Traffic Safety Administration reported that 1,105 bicyclists were killed in motor-vehicle traffic crashes in 2022, a 13% increase from 976 in 2021. In addition, the Consumer Product Safety Commission reports there were 405,411 emergency department-treated injuries associated with bicycles in 2022.

In New York City, last year was the deadliest year for cyclists since 1999, according to that city's Department of Transportation. Of the 30 cyclists who died in 2023 on NYC streets, 23 died riding e-bikes, which is more than double the previous record for e-bike fatalities. Serious injuries among cyclists in NYC went up last year as well, with a total of 395 cyclists who were severely injured, including 79 who were riding e-bikes, an increase of about 50 from the previous year.

The U.S. never is going to be Europe, where bicycling was a way of life before the automobile and the roadways in major cities were designed with bicycling in mind. We certainly would like to see safer roads for bicyclists in and around the Greater Boston area, especially if we can add dedicated bike paths. But until we have figured it out (and have the money to pay for it), we fear that more tragedies are inevitable.

#### DEJA VU ALL OVER AGAIN FOR LONG-TIME SOX, **PATS FANS**

The Red Sox once again are on the outside looking in. The Sox have failed to make the playoffs for the third year in a row and the fifth time in six years. The Sox had appeared destined for a playoff spot at the midseason All-Star break, only to falter miserably in the second half of the season, a pattern of the past three years.

As for the pathetic Patriots, it's hard to imagine them winning more than one or two games for the remainder of the year, which means they will finish up even worse than last year's four-win team, leaving them out of the playoffs for the fourth season in the past five. Even worse to contemplate is that the future for the Pats appears dim. As long as Allen, Mahomes, and Jackson are still in their prime, the Pats at best will be a .500 ballclub for the next decade.

Although both the Sox and the Pats enjoyed incredible success in the first two decades of this century, the downward trajectory for both teams is not all that surprising. The Sox and the Pats may be rated among the most valuable sports franchises in the world -- the Patriots recently were ranked the fourth most-valuable NFL team -- but the ownerships of both teams take their incredibly loyal fan base for granted and appear disinterested in constructing a championship-caliber team.

The Pats' demise must be particularly galling for owner Bob Kraft, who often speaks of being a Patriot fan from the founding of the franchise in 1960 and then enduring the decades when the Patriots were among the worst teams in the NFL.

Although younger Boston sports fans came of age during a 20-year period of excellence, the woeful performances of the Sox and the Pats these days bring back sad memories for older fans of the early 1960s for the Red Sox ("When April's high expectations turned to September's tears", in the words of Ken Coleman on the Impossible Dream record) and the latter half of that decade when the Pats were the worst team in the NFL.

Ironically, when the Pats and the Sox were awful in that era, it was the Celtics who brought us success with their incredible run of NBA titles led by Bill Russell -and once again the Celts seem to be our only hope for

joy once again, just as they were six decades ago. With the tough summer for Sox fans behind us and the fall football season fast-forwarding (so it ends quickly) for the Patriots, hopefully the Celts will bring us some

salvation this coming winter and spring.

Speeding from July-Sept 15th) as well as pedestrian and bicycle safety enforcement overtime; both initiatives will be targeting busy streets like Broadway and Eastern Avenue.

Grants funds will also be utilized to fund 2 pole-mounted speed radar signs with cloud based equipment management capabilities so we can operate them remotely. This will be a great resource for traffic studies.

"Lastly, we always request funds to purchase bicycle helmets for children ages 6-11," Maltez said. "The Community Services Division has previously participated in the MGH Chelsea Summer Safety Bike Fair and the Chelsea Recreation Bike Rodeo, incorporating the helmets into the educational component requirement per the grant. This year we were also approved for bicycle safety educational books. We plan on having a bicycle safety station at National Night Out next year."

Funds awarded to municipal police departments through the Municipal Road Safety Grant Program allows the departments to afford initiatives that include conducting traffic safety enforcement, bicyclist and pedestrian safety enforcement, non-enforcement activities such as trainings or community events, and purchasing traffic safety equipment or safety items to distribute in the community such as bike helmets. This year, OGR awarded \$5,637,336.83 to 191 departments - a record number of recipients for the program.

On the 2024 MCAS (Massachusetts Comprehensive Assessment System) Chelsea Public Schools' (CPS) test scores reflect alignment with statewide patterns. School Committee Chair, Ana Hernandez, expressed pride in the achievement, stating, "We are incredibly proud of the hard work and determination exhibited by all our students and educators. The recognition of Berkowitz Elementary as a 'School of Recognition' is a testament of high-quality teaching and a supportive environment of excellence that we strive to create at all schools." 

## MBTA launches NextGen Bus Navigation Pilot Program, employees to use new digital tools

The MBTA announced the beginning of its new NextGen Bus Navigation Pilot Program, a new initiative designed to assist bus operators in navigating detours and other road challenges. In partnership with Swiftly, a transit technology company committed to open data and interoperability, offthe-shelf tablet technology will be piloted in the operator cabs of up to 100 buses by the end of the year, providing turn-by-turn directions similar to navigation apps like Google Maps or Apple Maps. The NextGen Bus Navigation Pilot is supported by major new features in Skate, the MBTA's internally managed bus dispatching app, which allow the MBTA's Operations Control Center to map out, monitor, and manage unplanned bus de-

tours on-the-fly. "This technology is a step forward in improving service for customers and supporting our drivers who need to be nimble when unforeseen obstacles get in the way of running vehicles on regular routes," said MassDOT Secretary and CEO Monica Tibbits-Nutt. "MBTA bus service is a great option for travel and we believe the new technology will result in more efficient bus service, reduced travel times, and improved service reliability.'

"As we continue to improve bus service for our riders, it's important to put our workforce in a better position to succeed. We all know how the ability to navigate our road network can vary from day to day, and even hour by hour,

affecting travel times. We are utilizing technology to give our dispatchers and operators the tools to make timely decisions and deliver improved and more reliable travel for our riders. The NextGen Bus Navigation Pilot does just that," said MBTA General Manager and CEO Phillip Eng. "Providing our frontline bus operators with turn-by-turn directions is another example of the investments we're making in our workforce, building a more resilient and nimble transit system. Credit goes to our Technology and Operations teams along with our Safety Division that have worked to ensure the NextGen Bus Navigation Pilot Program is safely implemented."

Automobile drivers increasingly use navigation apps like Google Maps or Apple Maps for turn-byturn directions, which typically provide the fastest, most efficient route. However, the needs of the MB-TA's buses, which operate along fixed routes making hundreds of scheduled stops at bus stops, are very different. During special events, closed streets, and unplanned subway service suspensions, MBTA buses follow approved detours and shuttle bus accommodations provided by the Control Center, which can sometimes be complicated by narrow and winding

streets. In designing and implementing the NextGen Bus Navigation Pilot, the MBTA addressed these challenges by:

Using modern practices from the technology industry: Rather than relying purely on proprietary systems, the MBTA combined its in-house software engineering staff experts with an in-development tool from Swiftly.

Centering safety: Minimizing distractions is even more important for bus operators than for most drivers given their varied responsibilities riders safe. The MBTA's Safety Division has been engaged since this pilot's inception, orchestrating testing and planning that helped Swiftly and internal technology staff ensure that the pilot technology is supportive, not distracting, for bus operators.

Listening to front-line staff: For almost a year, the MBTA and Swiftly iterated and tested with bus operators, inspectors, and dispatchers, ensuring that the turn-by-turn software and new detour features in Skate reflect the input and expertise of front-line staff.

"Providing safe and reliable service is the core to everything we do at the T — and that starts with supporting our operators," said MBTA Director of Bus Safety Asia Williams. "Turn-by-turn navigation will ensure a seamless transition as the T continues to update its routes and reinforce bus operators' existing knowledge, giving them more confidence. We tested this feature with our operators and instructors to ensure that the technology works seamlessly in real-world conditions, creating a safer on-board ex-

perience." Swiftly's navigation solution will provide bus operators audible and visual turn-by-turn directions from a low-cost, off-theshelf tablet. Concurrently,

new features in the internal Skate app allow bus dispatchers to draw detours on a map from the Control Center – Skate then allows these detour maps to be shared with inspectors and other staff who manage service in real time across the system. The MBTA plans to eventually push these detour directions to the in-cab Swiftly tablets, and ultimately also to bus riders via industry-standard real-time open data

"We are delighted to partner with the MBTA to bring a modern navigation experience for the unique concerns of transit to life," said Swiftly's Chief Product Officer Meredith Bordoni. "With Navigation in Onboard App, transit agencies can prevent wrong turns, improve service reliability and safety, guide operators through detours, and build operator confidence. While feedback from dozens of transit agencies informed Swiftly's approach, the MBTA's unique open data standard orientation and innovative development approach made the agency an extraordinary partner in solving transit navigation challenges for the whole

industry." By building on a combination of in-house tools, off-the-shelf hardware, and modern vendors like Swiftly, the MBTA is preparing for future innovation and iteration. In an industry where technology can often remain stagnant, the MBTA's Technology Innovation Department can iterate quickly based on feedback from dispatchers and other front-line staff.

"We've hired over 350 new operators in the last year. Though we train operators on all routes, it still can be a nerve-wracking experience to get out on the road for new operators," said MBTA Executive Director of Bus Transportation Sean Mills. "This helps provide them with more confidence to learn more routes and be able to cover what would otherwise be dropped trips, when they have availabili-

"The team has built the detours feature with dispatchers, for dispatchers," said MBTA Bus Dispatcher Byron Randolph. "They've done it by spending time learning from us, speaking our language, and understanding our needs. I appreciate what the team has built. It'll make detour management so much easier for dispatchers by saving us time and improving how we work with staff in

the field." The MBTA will monitor the NextGen Bus Navigation Pilot over the fall and the winter 2024/2025. Following this evaluation period, the new technologies will be prepared to roll out to all bus garages with detailed real-time bus detour information available for riders too.

Animal guardians have two types of emergency situations where planning ahead will make things easier and less stressful. The first is an occurrence where you might have to leave your home with your pet to shelter elsewhere or a call to "shelter in place" with the needed preparation and supplies. The second is the need for an emergency visit to a veterinarian for a sudden illness or injury.

#### Weather and Other **Emergencies**

The heart of hurricane season is here. If you

have companion animals, you need a plan because, should a storm or other disaster strike, you are on your own when finding shelter for your entire family.


You must plan a safe place to go with your animals in an emergency. While large-scale disasters come to mind, it could also be water leaks or fires in your building. Sadly, the organizations that provide shelters for people often prohibit animals.

A friend or relative who will shelter you for a few days is ideal. You should also have the phone numbers of a few pet-friendly birds should be certain to

hotels near your home and surrounding areas, where you might reserve a room until the immediate danger has passed and those charged with emergency management begin to offer solutions for families with animals.

#### **Escape Plan and Kit**

The MSPCA and Animal Rescue League have created comprehensive and helpful collections of disaster planning resources on their websites. These will provide you with a checklist of items to gather and resources to have on hand. Those with cats and

in an easy-to-access spot. Poppy has a red kit bag filled with emergency supplies. We use it when we travel and would take it if we needed to evacuate. This bag has been used more often as a first aid kit than for a significant emergency, an added incentive to have one for your animals. Our family escape bag has our own supplies, plus emergency food and water for her.

**Trip to the Animal ER** Do you know your current options for an emergency room visit for a sick or injured pet? When we meet new neighbors, they often ask if we can recommend a veterinarian.

We're happy to tell them about the veterinary hospital we use and our favorite home-visit vet. We also tell them the location of animal hospitals offering round-the-clock emergency care and specific specialists. If they're new to the area, we suggest they know exactly how they would get to these facili-


If they, like us, are carfree, we suggest they have a plan to transport their animal to a vet by public transportation, a car service, or, best of all, by a friend or neighbor with a

We've noticed more and expanded veterinary clinics and 24-hour emergency veterinary care services opening in our area. We suggest you search, list those nearest you, and add the numbers for those places to your phone. Calling ahead is always a good idea in an emergency, not only to confirm availability and wait times. This call can also guide what you should do on the way

to professional care. We keep our dog Poppy's medical records in cloud storage. This way, we don't have to remember the details and can give any veterinarian access to the records from our regular care providers if needed.
