La Colaborativa recently announced the launch of its Climate Future Initiative, the largest climate-tech workforce training, career readiness, and economic development program in the Metro North Region.

In total, the multilingual program represents a \$2 million investment overseen by La Colaborativa, with financing provided by the U.S. Department of Labor through Senators Warren and Markey, coupled with major grants through the Mass. Clean Energy Center (Mass-CEC), the Executive Office of Economic Development (EOED), and MassHire Metro North Workforce Board. It sets the stage for the development of La Colaborativa's Center for Economic Development at 50 Heard St.

"Through a cross-sector partnership convened by La Colaborativa, this approach recognizes that we can only overcome the displacement crisis, poverty, and community violence by deliberately

Chelsea Police Department sends officers to National Women in Law Enforcement Training

The Chelsea Police Department recently sent three female officers; Officer Jennifer Herrera, Officer Jenny Builes, and Detective Taisha Santiago to participate in an intensive leadership enrichment training program in Atlanta in November.

This initiative reflects the department's ongoing commitment to developing future female leaders within the Chelsea Police Department, according to Police Chief Keith Houghton. The three officers were the second group of CPD female officers to attend this training. Three officers participated in the previous session in New Orleans in April 2024.

The training program, a nationally recognized leadership development course, provides participants with advanced skills in decision-making, communication, crisis management, and community engagement. By investing in the professional growth of its officers, the Chelsea Police Department is paving the way for a more inclusive and dynamic leadership team, Houghton added.

"Our department thrives when we nurture and empower the diverse talent within our ranks," said Houghton. "These three officers exemplify dedication and potential, and I am confident that this training will further enhance their ability to lead, inspire, and serve the Chelsea community."

Houghton said the officers selected for the program were chosen based on their commitment to the values of the Chelsea Police Department. This opportunity aligns with CPD's broader mission to foster an equitable workplace and provide high-quality service to the community.

"By investing in these officers, we are not only strengthening the Chelsea Police Department but also sending a clear message: the future of law enforcement is inclusive, and we are proud to be leaders in that effort," Houghton stated.

He said the Chelsea Police Department looks forward to the insights and skills these officers will bring back to further enrich the department and continue its tradition of excellence in public service. The department will send four more officers to the 2025 National Woman in Law Enforcement training in Kentucky and continue prioritizing training for its female officers.

Chelsea in talks to join Revere and Winthrop in regional dispatch operations

Chelsea could be joining the Metro North Regional Emergency Communication Center (RECC) alongside neighbors Winthrop and Revere within the next several years, according to a joint letter from the leaders of the three communities.

"This initiative, which has been in the works for nearly a decade, aims to combine our 911 dispatch operations into a shared, state-of-the-art facility at the McKinley School in Revere," stated the letter from Winthrop Town Manager Tony Marino, Revere Mayor Patrick Keefe, and Chelsea City Manager Fidel Maltez. "This move follows a growing trend across Massachusetts and represents a strategic effort to enhance public safety for our communities."

According to the letter, it is still early in the process for Chelsea to join Winthrop and Revere in the RECC, but it did highlight several potential benefits to Chelsea if it joins the partnership. "By consolidating our dispatch teams, we will improve our ability to respond to emergency calls, particularly during high-demand periods. Instead of relying on smaller, individual teams, the RECC will house a centralized group of up to 16 dispatchers, more efficiently providing our public safety personnel with the critical support they need," the letter states. "We will be able to share resources, reduce response times, and standardize protocols for a more consistent level of service. The RECC will offer a more robust mutual aid system than what curAccording to the community leaders, this means that when one community experiences a surge in calls, others can more easily assist, ensuring that no town or city is overwhelmed, and nobody is left behind. This collaboration would also reduce risk and improve safety for everyone, the letter

states. For our dedicated 911 dispatch staff, we want to emphasize that all current employees will remain in their roles and will receive comprehensive training to ensure smooth operation at our new facility," the letter states. "While we look forward to meeting with our employees' unions to hear their concerns and proposals about the impacts of regionalization, our goal and expectation is that negotiations will result in employees carrying over their seniority, pay rates, and benefits. Additionally, the RECC will feature modern amenities, including a lunchroom, training center, and fitness center, ensuring our staff continues to work in a positive and supportive environment." Maltez, Marino, and Keefe stated that they also wanted to reassure residents that the individual communities' public safety personnel-police, fire, and emergency medical teams-will remain in their respective communities and that the change solely involves the relocation of dispatch operations to the new RECC, which is 1.6 miles away from Chelsea City Hall. "Regionalization reflects our commitment to prioritizing public safety and ensuring that our communities are equipped to

respond to emergencies as efficiently and effectively as possible," the letter states. "We are confident that this initiative will strengthen our region's ability to protect and serve you, and we look forward to keeping you informed as we move forward with this important project."

Maltez said the three communities want to keep residents informed about the potential plans, and that it would likely be 2027 before the new operations center in Revere is ready to go and Chelsea is fully a member of the regional center.

The city's current E-911 center abutting the city hall parking lot was recently renovated.

Maltez noted that the renovations to the building were needed and were paid for through ARPA Covid relief funds. If Chelsea officially joins the regional communications center, Maltez noted that the building will likely be used to help with existing public safety space concerns in the police and fire departments. Currently, The Metro North Regional Emergency Communications Center receives over 30,000 911 and other emergency calls and alarms annually and manages the coordinated dispatch of police, and fire services for Revere and Winthrop, according to its website. It also transfers to other agencies for emergency medical services (EMS) and other resources. The staff also handles over 100,000 non-emergency calls annually regarding quality-of-life issues related to noise, traffic, lost property, and after-hours information for the communities it serves.

stakeholders before voting on the resolution.

The resolution also calls for the district to show its commitment to welcome, affirm, support, and educate students with diverse gender identities, expressions and sexual orientations, including transgender and nonbinary students. In addition, Neville's resolution asks the Chelsea Public Schools to call upon the state, the city, and all allied organizations and funders to assist in providing financial support to the district in the event that the US federal government fails to provide Chelsea with the funds necessary to educate all students in line with the commitments highlighted in the resolution.

of Education, and we get 15 percent of our budget from the federal Department of Education," said Neville. "We also know there is a chance he is going to try to attach strings to these grants."

Neville said the school committee and the district needs to look ahead and are many more students who identify that way now than they did when I first started teaching."

Wendy Mancia, the program director for Youth Elemento under North Suffolk Community Services, submitted a letter to the committee in favor of the resolution. "I had the opportunity to open a drop-in center in Chelsea that supports immigrant youth, LGBTQ youth and any youth look ing for a support system,' Mancia stated. "What I see now at my line of work is youth that come into this country without their family, without work permits, without their community I see families that want to move forward but cannot due to the multiple barriers they face. I see LGBTQ youth that have no other support system other than our program. "Many of the youth we serve are in therapy due to their challenges in life," Mancia continued "Sometimes I think, what if we did not have this center? Where would they be? Who would they go to for support? How would they access therapy without health insurance? I think it is imperative to continue funding and to continue supporting immigrant and LGBTQ youth. Chelsea resolved in 2007 to go on record as a Sanctuary City, to not initiate or welcome raids that are not related to public safety and other heinous crimes, and reject the use of the word "illegal" and "alien" to describe any human being. "Our mission statement (as a district) is that we welcome and educate all and we mean that," said Superintendent of Schools Dr. Almi Abeyta. "We also protect the privacy of our students, and that is not going to change."

"As we all know, the presidential election this year is difficult for Chelsea because the president who was elected promised to deport as many undocumented immigrants as he could, and that is going to have a big impact on Chelsea if he manages to do that," said Neville. "I thought it was publicly important to state and reaffirm our commitment to our families because we all know that making undocumented families feel safe and welcomed is really important to the health and wellness to our city as a whole because then people feel unsafe, they will hide from services and supports that are meant to help them."

Neville noted that there is also a heightened rhetoric around transgender people and students, and that it is important for the district to let them know that it is committed to welcoming and affirming their identities.

"Most importantly, we know that there is a chance that the incoming president is going to try and dismantle the Department prepare for that possibility and lobby the state, the city, and other organizations to plan and help in case Chelsea and other gateway communities see their federal funding for education slashed.

School Committee Chair Ana Hernandez said the committee should further discuss and evaluate the proposed resolution in a separate committee after getting guidance from legal counsel and input from other political partners.

"It is a wonderful motion," said Hernandez. "We are trying to make it as strong as we possibly can and educate all of us as a committee so we can all be on the same page."

The date of that committee meeting on the resolution had not been set as of early this week, according to Neville.

Browne Middle School teacher and Chelsea Teachers' Union President spoke in favor of the resolution at last week's meeting.

"Back in 2016, when there were similar election outcomes, students directly expressed extreme anxiety to me and concerns about themselves or their families having to leave the country forcibly," said Anderson. "I think taking a minute to really reaffirm to our commitment that we truly welcome and educate all students is important to do explicitly. I especially appreciate the inclusion of students who are gender nonconforming or gender diverse; it is a community that is growing and there

Chelsea man held without bail in shooting death of estranged wife

Staff Report

A Chelsea man is being held without bail for first-degree murder in connection with the shooting death of his estranged wife on Marginal Street last Friday.

Luckenson King Pablo, 31, was arrested hours after the shooting at an Everett apartment building by Chelsea Police with assistance from the Massachusetts State Police and Everett Police.

King Pablo was arraigned in Chelsea District Court on Monday for the murder of his estranged wife, Melissa Janvier Pablo, 32.

"This was a fast-moving investigation involving State and Chelsea police with an important assist by Everett police," said Suffolk County District Attorney Kevin Hayden. "I thank all for their solid work to ensure that Mr. Pablo will answer for this brutal crime."

Chelsea Police Chief

Keith Houghton stated "evidence suggests this was a targeted attack and no one from the public is in danger. I want to thank all Chelsea Officers who responded to the call and rendered aid, also thanks to the State Police Detectives who are assigned to the Suffolk County District Attorney's Office, and the Everett Police Department, who worked together to swiftly place the

suspect in custody," Shortly before 8:45 a.m. on Friday morning, Houghton stated that a Chelsea police officer on patrol in the area of Central Avenue at Marginal Street by the TownePlace Suites reported hearing shots fired and located a female victim on the ground.

The woman, later identified as Janvier Pablo, was transported to Massachusetts General Hospital, where she was later pronounced dead.

According to the dis-

Keith Houghton stated trict attorney's office, the "evidence suggests this shooter ran from the scene was a targeted attack and and fled in a car.

"Losing someone so young to such a shocking act of violence is heartbreaking for family and friends and for our entire community," said Hayden. "I thank everyone who is working on this tragic case and I offer my deepest condolences to all those who knew and loved Melissa Pablo."

During the arraignment, prosecutor Kyle Siconolfi said it was alleged that the defendant approached the victim and she attempted to get away from him, that he physically assaulted her, that she ran from him, that he pursued her, and that when the victim fell at the median of Marginal Street and was on the ground with her body half raised in the direction of the defendant, that he pointed what appeared to be a firearm at her in her upper body and she fell fully to the street.

Chelsea man sentenced for selling fake Social Security cards and Green Cards

A Chelsea man was sentenced last week for selling fraudulent Social Security cards and Legal Permanent Resident cards, often referred to as "Green Cards."

Wilberto Sandoval Mazariego, 41, was sentenced by U.S. District Court Judge Allison D. Burroughs to one month in prison, followed by six months of home confinement. In July 2024, Sandoval Mazariego pleaded guilty to one count of unlawful transfer of a document or authentication feature. In October 2023, Sandoval Mazariego was arrested and charged by criminal complaint and

Sandoval Mazariego was identified as the creator of the fraudulent documents Xirum was selling. Following Xirum's arrest in August 2022, a text message string was discovered between Xirum and Sandoval Mazariego that contained approximately 568 attachments. Xirum would regularly text Sandoval Mazariego pictures of unknown persons along with a name, date of birth and country of birth – to which Sandoval Mazariego would later respond with pictures of Social Security cards and/or Green Cards with a person's photo and information that Xirum provided, according to the

U.S. Attorney's office. On Aug. 17, 2023, Sandoval Mazariego sold a a search of his residence, all items necessary to produce counterfeit forms of identification were found, including two laminators, card stock paper, photo paper, glue, trimmers and printers. Also recovered were nine Legal Permanent Resident cards, six Social Security cards and five driver's licenses. Five of the recovered Social Security cards contained the names provided by the undercover agent to Sandoval Mazariego as part of the investigation. A total of \$17,095 in cash was also recovered from the residence, according to the U.S. Attorney's office.

DOMESTIC VIOLENCE: THE SCOURGE WITHOUT END

When we heard the news last Friday morning that a 32 year-old woman had been shot and killed in broad daylight on a busy Chelsea street, the first thought that immediately crossed our mind was: The husband or boyfriend did it. Just a few hours later, police announced that they had arrested a suspect, the victim's 31 year-old estranged husband who, according to news reports, had called police to turn himself in.

We've been in the news business for longer than we care to remember and the world has changed in ways that were unimaginable when we began our career in journalism more than 50 years ago. But despite the changes in technology and societal attitudes regarding countless issues, the one constant that has remained is the pathology of domestic violence.

It still is the case today, just as it always has been, that a woman is more likely to suffer violence by a partner than from any other source. The statistics tell the tragic story: Nearly half of all women murdered in the United States are killed by a current or former intimate partner; 1 in 4 women will experience physical violence from an intimate partner in their lifetime; 1 in 3 women will experience some form of sexual violence from an intimate partner in their lifetime; and 1 in 6 women will experience stalking from an intimate partner in their lifetime.

It also has remained true that the most dangerous time for a woman in a relationship is the period when she first decides to leave her partner. The victim in the shooting this past week had been married to the suspect for 10 years, but they had become estranged only within the past two weeks.

In addition, an article in this week's New York Times has highlighted another dangerous time period for women: According to the Times, the second-leading cause of death (other than from the pregnancy itself) for women who are pregnant or recently postpartum is domestic violence.

What also was not surprising about Friday's tragic event is that a gun was used by the perpetrator. The mere presence of a firearm in a domestic violence situation increases the risk of homicide by 500% and more than half of intimate partner homicides are by firearm.

Fortunately, the U.S. Supreme Court recently let stand laws that exist in every state that require a person with a domestic violence restraining order to turn in his guns. However, there had not been a restraining order between the parties involved in Friday's tragedy.

Domestic violence cuts across all racial and economic lines. Just the week before Friday's incident (in which the victim and the suspect, both of whom are Haitian immigrants and are Black), it was announced that the Cohasset man who allegedly murdered and dismembered his wife -- both of whom are white -- at Christmas time two years ago will stand trial next year. We also would note that today's Massachusetts domestic violence laws stem from the 1970s after an incident in that wealthy suburb of Cohasset in which the husband shot and killed his wife and then shot and wounded his children before turning the gun on himself. We generally conclude our editorials by offering our view on what lawmakers or individuals can do in order to bring about societal change. However, when it comes to domestic violence, we have no ready solution to this long-standing problem. We can only recommend to women and anyone who is in an abusive relationship to end it immediately and seek help from law enforcement, the courts, and the many services available to victims of domestic violence in our communities. Domestic Violence vigil planned for City Hall

HarborCOV, the local domestic violence program serving Chelsea, East Boston, Winthrop, and Charlestown is partnering with the City of Chelsea and the Chelsea Women's Commission to remember Melissa Janvier Pablo with a vigil at Chelsea City Hall on Thursday.

Pablo died on Dec. 6 after allegedly being shot by her estranged husband outside a Chelsea hotel.

Luckenson King Pablo, 31, was arrested hours after the shooting at an Everett apartment building by Chelsea Police and was later arraigned on murder charges in Chelsea District Court and ordered held without bail.

"This terrible loss underscores the urgent need for us to unite in the fight against domestic violence and to stand in solidarity with survivors," said Chelsea City Council President Norieliz DeJesus. "As City Council President, I extend my

families and loved ones affected. The Chelsea City Council remains steadfast in its commitment to providing essential resources, unwavering support, and hope for those in need. We will continue to work together with compassion and determination to create a community where safety, dignity, and respect are the foundation for all."

In partnership with the City of Chelsea and Chelsea Women's Commission and community groups, HarborCOV will host a community vigil on Thursday, December 12, 2024, at 6 PM on the Chelsea City Hall to honor the life of Melissa Janvier Pablo and raise awareness about the lethality of domestic violence.

"This tragic incident underscores the ongoing dangers that many victims of domestic violence face, especially when attempting to escape an abusive relationship. It's important to recognize that leaving an abusive partner can

State grant could help fund warming center

Chelsea could be joining other local communities in opening a warming center for homeless people this winter.

Malden and Revere have operated overnight warming shelters for several years.

The city has applied for a grant from the state's Executive Office of Housing and Liveable Communities that would help cover the start-up costs for the center. The center is being proposed at the Se-Iah Day Resource Center on Broadway.

rities and individuals experiencing homelessness and drug addictions problems.

The grant application calls for the center to operate nightly from 7:00 p.m. to 7:00 a.m., from January 1 through April 30, 2025.

"The center will provide shelter, meals, and critical connections to services that will support individuals in transitioning to permanent housing and accessing mental health programs," according to the grant application. "The warming center will be designed to serve underserved, Chelsea's populations, vulnerable with particular attention to undocumented migrants and other marginalized groups. In addition to providing life-saving shelter,

the center will connect individuals to essential case management services and resources aimed at fostering long-term housing stability and overall well-being.'

Housing Families, in collaboration with local health and human services agencies, such as Capic and North Shore Community Services Navigators, will ensure that guests are linked to case

management services. Housing Families will oversee intake and work to connect individuals to long-term housing, legal support, healthcare, and other vital services. Housing Families has also operated the overnight warming shelter in Revere at its senior center for the past two years.

"Revere has done a warming center for several years and it has been incredibly helpful," said City Manager Fidel Maltez. "This year is the first year we have been looking into this setup, and what has really made this available is that there is a new grant available.'

Maltez said the city already partners with the Selah resource center, so it would make sense to continue the partnership with the warming center.

ANOTHER DICTATOR **BITES THE DUST**

The demise of the dictatorship in Syria this weekend that brought to an end 50 years of brutal rule by the Assad family -- Bashir al-Assad had succeeded his father, Hafez al-Assad -- was startling to most observers. The Assad regime had successfully fought off a rebel army more than a decade ago, and though Syria had been divided into areas of control by various rebel groups and the government, the Assad regime, bolstered by the Russians and the Iranians, seemed secure.

However, the denigration of Iran's military capabilities by Israel this past year and Russia's weakened position because of its war in Ukraine left the Assad regime vulnerable to the rebel factions who never had gone away over the past decade.

What caught everyone by surprise, including Bashir al-Assad himself, was the rapidity of the rebels' advance from their stronghold in a tiny portion of northwestern Syria in the city of Idlib to the capital of Damascus, hundreds of miles away.

The images of Syrians rejoicing in the streets amidst the toppled statues of Hafez al-Assad were reminiscent of what happened in the immediate aftermath of the fall of so many other Middle East dictators, including Saddam Hussein in Iraq and Muammar al-Gaddafi in Libya.

The quick end to the al-Assad regime brought to mind a phrase by a character in the novel, The Sun Also Rises by Ernest Hemingway, about how bankruptcy befalls someone: "Gradually and then suddenly."

We join with the Syrian people in their joy and pray that their future, whatever path it may take, will be peaceful.







Old North Church undergoing paint conservation and restoration project

An interior revolution is underway at Boston's Old North Church and Historic Site. On Sept 30, a 6-month paint conservation and restoration project began to uncover 18th-century painted angels hidden beneath layers of white overpaint on the balcony arches in the church's sanctuary. I invite you to join renowned paintings and murals conservator Gianfranco Pocobene for the multi-step process that has begun at Old North Church in Boston's North End and will continue through late March.

The angels at the center of this work were painted by John Gibbs, an accomplished decorative painter and congregation member, who completed Old North Church's first major interior decoration, including the painting of 16 angels, between 1727 and the 1730s. The angels are depicted as cherubs, with round childlike faces and wings.

While Old North Church once boasted a colorful interior filled with intricate and ornate designs, all of this artwork - including Gibbs's angels - was painted over with white paint in 1912. However, a paint study conducted in 2017 revealed that the lost cherubs still exist. Expert craftspeople painstakingly removed layers of white paint to partially uncover one of the angels painted in 1727. Old North's team nicknamed this angel "Howard" in honor of a beloved advocate and supporter of the church.

The 2024-2025 paint restoration project is restoring more of Gibbs's work: the rest of the angels and decorative festoons between them. In order to uncover the angels, lead conservator Gianfranco Pocobene and his team apply a solvent gel similar to a paint stripper that softens the layers of white paint, manually remove the overpaint with a plastic scraper, and then do additional cleaning with a cotton swab covered in solvents. An exciting discovery has been that Gibbs's angels do not have identical faces; each one was designed to be unique. Watch this video interview with Gianfranco to learn more.

"The timing of this project is particularly exciting. As we approach the 250th anniversary of Old North's signal lanterns and Paul Revere's midnight ride in April 2025, visitors to the church will get a glimpse of the sanctuary as Revere knew it," said Nikki Stewart, Executive Director of Old North Illuminated.

This project will be done in two phases:

• Phase 1 (through Dec.): Gianfranco and his team will work on scaffolding in the rear of the church while they conduct the work and test solvent

mixtures on small areas of paint. The winning solution will be used on the surface to swell and dissolve an estimated three to four layers of paint, which will be delicately stripped away to reveal 8 of the hidden angels. The project will then pause as scaffolding will come down for holiday services in the church.

• Phase 2 (mid-Jan. through late March): Scaffolding will go back up in the front of the church to continue the stripping process. Eight more angels will be revealed. In early 2025, visitors will see half of the work complete and the other half in progress, making it an ideal time for media coverage. The grand reveal, when all 16 angels will be uncovered, will be in April.

"The step-by-step uncovering of the angels at Old North Church is revealing fascinating aspects of John Gibbs's painting technique," said Gianfranco. "Even more intriguing and exciting is the opportunity to conserve and restore some of the earliest paint decorations in America and make them accessible to the public and scholars alike.'

Born in Italy and raised in Canada, Gianfranco received his Master of Arts in Conservation from Queen's University, Kingston, Ontario in 1984. He first came to Boston in the 1980s to earn a Certificate of Advanced Training

servation and Technical Studies at Harvard Art Museums. He then spent the next 15 years working for the Straus Center for Conservation, Harvard Art Museums where he oversaw the restoration of mural cycles at the Boston Public Library by Puvis de Chavannes, Edwin Austin Abbey, and John Singer Sargent. In 2004, he was appointed Chief Conservator at the Isabella Stewart Gardner Museum where he carried out treatments and technical studies on the paintings collection. Early this year he left the Gardner Museum to focus exclusively on his private practice, Gianfranco Pocobene Studio which





Maybe It's Not Old Age

Some things we consider old age can also be signs of pain. Changes in appetite, routine, getting up slowly, heavy panting, grumbling, and being a bit grumpy can happen as pets age, but these are all signs of pain as well. If a dog changes her sleeping position, has more accidents in the house, doesn't want to play, or avoids jumping up on a chair or sofa, you should note the behavior and report it to your vet.

medications at these sessions. Weight control is even more critical in seniors. It takes teamwork to help a dog lose weight. Make sure you have every member of your household on the team. Discuss your specific guidelines for feeding, restricting extra calories, and exercising to anyone who will be pet sitting, providing daycare, or boarding your senior dog.

Improvements in veterinary science, nutrition, and pet guardian education are helping our dogs and cats live longer, healthier lives. After treatment for something other than old age, that old dog may bring you a leash or a favorite toy.

Keep up the Exercise

We all understand that daily exercise is essential for dogs' physical conditioning and weight control. However, more and more research tells us that exercising the brain is important to prevent dementia and improve dogs' quality of life. In dogs, dementia is called canine cognitive dysfunction (CCD). Many lifestyle habits that help human brain health also apply to dogs.

Think about how tired highly-activated brain cells make you when you take a class, learn a new skill, read up on a new topic, or spend time in a new setting or with new people. It can be exhausting. Remember this when deciding on the proper brain workout for your dog.

New sights and sounds may stimulate an older dog's brain. You can try walking in new places, training new behaviors, and playing games appropriate to a dog's age and physical abilities. Old dogs might enjoy a food puzzle toy that rewards their efforts to get at the food with a steady flow of treats. (Ensure those treats are healthy and part of your dog's daily food intake.)

Knowing your dog is vital. A devoted sniffer

may love a good game of find-the-snack. More time with other dogs and people may stimulate a social butterfly. A shy or anxious dog may prefer to sit back and watch or play a quiet game of "push that ball to me."

But Jeffrey Galpin did more than survive polio. He went on to a list of achievements in medical research—including being the principal investigator in applying the first


