City Manager proposes \$261.7 million budget

City Manager Fidel Maltez has officially submitted the City of Chelsea's proposed Fiscal Year 2026 (FY26) budget to the City Council, totaling \$261.7 million, marking a 6.82 percent increase over last year's budget. The proposed spending plan reflects the city's commitment to public safety, education, and infrastructure investment while maintaining a disciplined fiscal approach, according to Maltez.

"This budget continues to build on our investments in public safety, education, and infrastructure while maintaining fiscal discipline," said Maltez. "Chelsea's financial health remains strong, and we are focused

on balancing growth with affordability and essential services."

The general fund is proposed at \$110.8 million, while the school department would receive \$150.9 million, underscoring Chelsea's strong support for education, Maltez stated.

He added that public safety is a key priority in the FY26 proposal. "This funding ensures we can continue to invest in community policing initiatives and critical training to better serve all our residents," said Police Chief Keith Houghton.

Fire Chief John Quatieri also praised the proposed investments, noting, "With these resources, we will be able to modernize equip-

This competitive selection highlights Fields' exemplary leadership and commitment to advancing local government operations in Chelsea, according to City Manager Fidel Maltez.

As the Deputy City Manager of Operations, Fields oversees several key departments, including In-

DiDomenico provides update on Everett soccer stadium

State Senator Sal DiDomenico provided an update on plans for a new 25,000seat professional soccer stadium for the New England Revolution on the Everett waterfront at Monday night's Chelsea City Council meeting.

The state senator reviewed the history of the project to this point and discussed the methods that could be used to alleviate traffic from the stadium in Chelsea, Everett, and surrounding communities.

"The Revolution are proposing to build a soccer stadium on the waterfront in Everett, which currently looks like a place where we normally wouldn't do any business," said DiDomenico. "There is a power plant sitting there right now, and the power plant has been decommissioned and it's basically an empty shell. But what is left of the power plant is dirty soil, dirty water on the waterfront, and for years, that power plant has been polluting our air."

With the proposal for the soccer stadium, DiDomenico said Everett and the region are trying to turn the page on its industrial past.

"The challenge we had is that the power plant, where it sits today, is on a Designated Port Area (DPA),' DiDomenico.

The state senator said there are about 10 DPAs in the state, and that the one that runs from Everett through Chelsea is one of the largest in the state. With the DPA in place, DiDomenico said there has been little chance to properly develop the area.

"Through legislation, we lifted the DPA on that piece of land where the power plant is today and where the stadium is proposed to go," he said. "The DPA that was lifted was 8.8 percent of the entire DPA, so there is a much larger DPA that goes beyond that." That legislation passed last November, and the official lifting of the DPA is contingent upon the cities of Everett and Boston (which owns a small part of the proposed stadium site) signing an agreement

with Revolution owners the Kraft family on a community benefits agreement.

DiDomenico said that if there is not an agreement signed by May 1, it would then go to mediation with the communities. If the agreement was not resolved through mediation, it would then go to arbitration by the end of the year and the arbitrator would then come in to determine what was best for the communities.

One of the big issues that has come up in relation to the possible stadium construction has been the impact on traffic in Chelsea and throughout the region.

Part of the DPA legislation included a requirement that the MBTA put together a plan of how it plans to move 25,000 people to and from the stadium on game and event days.

"There are only 75 parking spaces at the site, and that was by design," said DiDomencio. "People have varying opinions on if that is good or bad. There is room to put a 10,000-car garage on that site, but by design, we eliminated parking because we know that if you put a garage there with a 10,000 car capacity, you will see more than 10,000 cars trying to get into that garage for every single game and concert.'

To make the stadium project work, DiDomenico said there has to be a robust transit plan.

The proposed transit plan for the stadium and the area includes the long-awaited commuter rail station behind the nearby Encore Casino, which the casino is committed to funding. DiDomenico said the rail station has been delayed because of the slope of the train tracks behind the casino, but that the latest train

um," said DiDomenico.

The funding for that project is already in place through the state's department of transportation and should be completed by 2029, which is when the stadium should be ready to go.

The last component of the transportation plan is a water shuttle on the docks adjacent to the stadium at the four-acre public waterfront part the Krafts have stated they will build and maintain.

"When all this is built out, it will be one of the most accessible transit-created corridors in the entire state," said DiDomenico. "This area has had no transit really for years, there was no reason to build anything in that area and it has been delayed because there was not a catalyst to make it happen. We knew when we proposed a soccer stadium on that site it would be the catalyst to make all the things that were on paper happen."

As the project gets underway, DiDomenico said Chelsea will have a voice to make sure it has limited impacts on the community, such as the environmental permitting process.

"There are several steps where the public will be engaged," he said. "There is a lot of excitement about this project, and I strongly believe this is a great project for our community and our region or I would not have put my name on it and put my reputation on the line and fought for this for almost three years to get it across the finish line.'

LYNN MAN **CHARGED WITH** CHELSEA MURDER

Carlos Utrera, 27, of Lynn, was arraigned on several charges, including first-degree murder, in connection with a fatal shooting that occurred Saturday morning at 40 Watts Street.

Chelsea Police detectives, working in collaboration with State Police detectives from the Suffolk County District Attorney's office, arrested Utrera later in the day on Saturday.

This arrest follows a swift and coordinated investigation by Chelsea Police and the Suffolk County State Police Detective Unit, according to Chelsea Police Chief Keith Houghton. The investigation remains active as authorities continue to pursue all leads related to this incident.

"We are committed to ensuring that those responsible for violent acts in our community are held accountable," said Chelsea Police Chief Keith Houghton. "I want to thank our detectives and the Suffolk County District Attorney's Office for their immediate and tireless work on this case."

Shortly after 12:30 a.m. on Saturday, Chelsea Police Officers responded to the area of 40 Watts Street following a report of a shooting. Upon arrival, officers located a 20-year-old male victim suffering from a gunshot wound. Despite life-saving efforts, the victim was pronounced dead, according to police.

On Monday, Utrera was charged with first-degree murder, carrying a firearm without a license, and carrying a loaded firearm without a license in Chelsea District Court. He was ordered held without bail and is due back in Chelsea District Court on June 12 for a probable cause hearing.

Council provided with feedback on parking fine fees

Parking on the congested streets of Chelsea has consistently been one of the biggest issues in the city.

At Monday night's city council meeting, City Manager Fidel Maltez responded to a council order filed by District 5 Councilor Lisa Santagate requesting the city review its existing structure for traffic and parking violations with an emphasis on overnight parking without a residential sticker.

"Our Director of Constituent Services completed a thorough review of neighboring communities," stated Maltez. "During our engagement with residents, parking is among the top concerns. We appreciate the concern raised by Councilor Santagate and agree whole-

heartedly that there needs to be an improvement within our current parking program to prioritize parking for our residents."

Chelsea's current structure for traffic and parking violations is comparable with surrounding communities, according to the city manager.

"The \$25 fee for parking without a residential sticker overnight is equal to that of our neighbors in Everett and Winthrop," Maltez stated. "While doing research for this council order, Everett announced that all parking fines would be increased by \$5 effective July 1, 2025. Revere currently charges \$20 for the same infraction. Somerville Charges \$50 for this infraction."

ing specific vehicles versus making a citywide change, according to Maltez.

In Everett, there is a \$50 fee for commercial vehicles and \$50 for an overnight parking violation.

"Everett also charges a different amount, \$50, for overnight parking fines in the downtown area," said Maltez. "We are mindful of striking the balance between effective parking enforcement and burdening residents with additional costs."

Santagate thanked Maltez and his office for the research they provided.

"That was really my goal with bringing this up was that we could start to have a conversation and start to think of other ways to tackle this issue," she said.

Councillor-at-Large Roberto Jimenez Rivera said there should be further conversation about the issue in the council's parking planning subcommittee. He said the council might also want to consider extending the hours of enforcement for the resident parking permits.

"Bans are not a way to make money, it is a way for us to enforce the rules, and if we don't want people parking we should look at increasing the fees so it prevents people from doing it," he said.

District 1 Councilor Todd Taylor said the council needs to gather more community input and engagement before it decides to discuss any changes in subcommittee.

The Neighborhood Developers acquires Park and Pearl properties to preserve affordable housing

The Neighborhood Developers (TND) has acquired a group of multifamily properties in Chelsea, a move aimed at preserving affordable housing and preventing displacement in the community. The properties include 148 Park Street, 158 Pearl Street, 156–160 Park Street, and 161-165 Pearl Street, totaling 30 residential units.

With resources from the Eastern Bank Foundation, Boston Impact Initiative, the City of Chelsea, and the Opportunity Communities (OppCo) Housing Accelerator Fund, TND was able to acquire these historic properties and ensure they remain affordable and in good condition for tenants. The acquisition and long-term sustainability of these properties was additionally supported with financing from MHIC NOAH Regional Fund and the Property and Casualty Initiative (PCI). In fact, TND was the first nonprofit to access MHIC's new NOAH Regional Fund, a fund set up to support acquisition of existing multi-family properties like ful to the donors and mis-

those at Park & Pearl.

"The Commonwealth's housing affordability crisis demands bold leadership, new strategies and innovative partnerships. PCI is proud to invest its capital alongside OppCo and MHIC to support TND's groundbreaking portfolio acquisition initiative that will preserve and deepen affordability at scale across Chelsea neighborhoods," said Michelle Volpe, President of PCI.

"The acquisition of Park and Pearl in Chelsea marks the first loan from MHIC's Regional NOAH Fund-an initiative designed to help mission-driven developers preserve at-risk, naturally affordable housing," said Moddie Turay, MHIC's President and CEO. "These 30 units, acquired by The Neighborhood Developers, represent the kind of unsubsidized housing that is rapidly disappearing across Massachusetts. By acting quickly, the fund protects affordability, prevents displacement, and secures long-term housing stability for our communities."


"We're deeply grate-

sion-driven investors who made this acquisition possible," said Kathy McGilvray, CEO of OppCo. "Their commitment allowed TND to act swiftly and secure these homes at Park and Pearl, protecting tenants and preserving affordability in Chelsea. TND, a member of OppCo, has made housing preservation a priority. The acquisition of these properties aligns with the organization's efforts to stabilize neighborhoods and support residents at risk of displacement.

"Thanks to the trust and investment of our funding partners, we were able to move quickly to preserve these homes for Chelsea residents," said Rafael Mares, Executive Director of TND. "Their support is a vote of confidence in our community and the people who live here. We're proud to partner with them to protect and improve and preserve the homes at Park and Pearl."

a family community," she said. "This is one of the biggest projects we've built, and it doesn't include families; and I have a real hard time with that, and the two elevators are never going to work."

The seven retail spaces range from about 700 to 1,700 square feet, but Rossi said there is the possibility that two or more units could be combined to create a larger retail space.

Since the project does not meet the required number of parking spaces for the zoning district, Rossi said residents would not be eligible to take part in the city's residential parking sticker program.

"We actually have more parking than other projects that were built in the Broadway district," said Rossi.

Rossi noted that a traffic analysis of the project was close to completion as of last week's public hearing.

The goal of the project with its large mix of one-bedroom units is to limit the amount of parking with the tenants who come in so that there is some parking remaining for visitors and the people who will work in the retail spaces, Rossi added.

Planning Board member Mimi Rancatore raised concerns about the retail units, as well as the development having only two elevators. In addition, Rancatore was one of several people to point out that Chelsea is in need of housing for families, not small, one-person units.

"Chelsea needs family housing, it doesn't need 95 micro units, that is not what Chelsea is, Chelsea is

Mark Lederman, who owns a property adjacent to the proposed project, said he also has many of the same concerns that were raised by Rancatore and Maynard.

"I'm concerned with the density, it is out of character with the neighborhood," he said. "I do want to see something developed over here, I just think some more work needs to be done with the neighborhood."

District 7 City Councilor Manuel Teshe also said the city needs more housing for families, and that he would like to see the developer come back with a slightly

based on the lot size," said Rossi. "This is 60 percent of an acre in downtown Chelsea. The reason it sounds like a lot is because my client has acquired multiple, multiple parcels and made them into one development project."

Rossi said he had no issue tabling the public hearing on the development to see if any adjustments could be made.

"My only concern is even if we reduce the unit count and add more multiple bedrooms, I'm thinking we're creating a bigger parking problem by doing that," said Rossi.

Decreasing the unit count would also decrease the number of affordable units in the project, Rossi noted, adding that financing for the project would be more difficult with a lower unit count and more affordable units.

The project will be back before the planning board at its May 27 meeting.

The planning board also continued the public hearing for a two-family home proposed for 18-24 Grandview Road. The applicants came back with a smaller proposal for a two-story house as opposed to a side-by-side duplex that was previously before the board, but neighbors and some board members said they still had concerns about parking and the impact the project would have on neighboring properties.

THE TRAGIC WAR IN VIETNAM ENDED 50 YEARS AGO THIS WEEK

It was 50 years ago this week on April 30, 1975, that the U.S. involvement in the War in Vietnam officially came to an end when the last U.S. military helicopter flew ignominiously from the roof of the U.S. Embassy in Saigon (as the capital of South Vietnam was known at that time, but which is now Ho Chi Minh City, named after the No. Vietnamese leader who once worked as a pastry chef in Boston's Parker House from 1911-13).

For the generations of Americans over the past 50 years who know about the Vietnam War only from their U.S. history classes, the few pages in their textbooks devoted to the war cannot even remotely describe both the upheaval that the war caused in American society at that time and the lasting impacts upon our nation that reverberate today.

More than nine million brave young Americans served during the war, of whom more than 58,000 gave their lives, while another 300,000 were wounded. In addition, there were hundreds of thousands more who suffered the psychological effects from PTSD, as well as the latent toll from Agent Orange (the powerful chemical herbicide that took its name from the orange striping on the barrels in which it was stored) and other weapons used by the U.S. military that resulted in later-life cancers and birth defects that affected tens of thousands of our soldiers and Vietnamese civilians.

For those of us who came of age during that era from 1965-75, we recall watching the war brought into our living rooms every night on the national TV news shows with reports from correspondents who were embedded with our military as they went on their infamous search and destroy missions that transformed the beautiful and placid Vietnamese countryside into a living hell for the Vietnamese people.

We recall reading with stunned disbelief in Time Magazine (Time was delivered to our home every week) about the massacre by U.S. Army American soldiers, led by Lieutenant William Calley, at the Vietnamese village of My Lai, in which hundreds of civilians, almost all of them women, children, and elderly men, were raped and murdered.

We remember the "body count" of "enemy soldiers" that was issued daily by U.S. military officials, under the direction of General William Westmoreland, which was so huge that it seemed that it would be only a matter of time before the small country of No. Vietnam would run out of soldiers.

Only later did we learn that these so-called body counts included hundreds of thousands of So. Vietnamese civilians who were killed by our bombs and assaults on their villages.

Then in 1971 came the publication of the Pentagon Papers, which had been leaked by Daniel Ellsberg to the New York Times, which detailed the secret history of the war (compiled by the Pentagon itself). The Pentagon Papers spelled out how President Lyndon Johnson and previous administrations had systematically lied both to the American people and Congress about what was going on in Vietnam. The Pentagon Papers detailed the covert actions by the U.S. military that involved us ever-deeper into the process of escalation that culminated with the Tonkin Gulf Resolution passed by Congress in August, 1964, that basically gave Johnson carte blanche to send millions of soldiers to Vietnam without Congress ever having issued a Declaration of War. Senator Ernest Gruening of Alaska was one of only two senators to oppose the resolution with words that would become prophetic, saying he was voting against the resolution because "...we are sending our American boys into combat in a war in which we have no business, which is not our war, into which we have been misguidedly drawn, and which is steadily being escalated."

Only years later was it revealed that the basis of the Tonkin Gulf Resolution -- the supposed attack on U.S. naval vessels by No. Vietnam in the Tonkin Gulf off the coast of No Vietnam -- was a complete fiction.

Moreover, the overall justification for the war was the oft-stated Domino Theory, by which American policy-makers suggested that if one country in Southeast Asia were to fall to the Communists, the others would fall like dominoes and would become vassal states of China and the Soviet / union.

But that analysis completely ignored the simple fact that the Vietnam War was a civil war in which the Vietnamese were seeking to throw off their colonial rulers -- the country had been invaded and governed first by the Chinese, then the Japanese, then the French, and then the Americans.

Robert McNamara, who served as Secretary of Defense under Presidents John F. Kennedy and Johnson from 1961-68, and who was one of the chief architects of the American strategy, admitted 40 years later that American involvement in the war in Vietnam was "wrong."

In the aftermath of the war, trust in our government reached an all-time low and has continued to plummet ever since, even among those of us who generally believe in the values of our democracy and the need for a strong national government.

The War in Vietnam was a tragedy for everyone who even remotely was touched by it. It was a war built on lies on top of lies -- and its legacy is a large part of the reason why Americans have such distrust of our government and institutions today. into Project Bread's decision-making, programming, and policy initiatives. The eight Council of Experts members, including Zuniga, of the 2023-2024 cohort contributed to projects like improving evaluation tools with the research team, refining communications for The Walk for Hunger, increasing awareness of nutri-

Federal Bureau of Investigation's Joint Terrorism Task Force turns 45

The Federal Bureau of Investigation (FBI) is marking the 45th anniversary of the creation of its first Joint Terrorism Task Force (JTTF). Formed in 1980, the first JTTF became a model for law enforcement cooperation across the nation.

The Boston Division of the FBI organized its first JTTF in April 1986. Known as the New England Terrorism Task Force, it was comprised of the FBI, the Boston and Cambridge Police Departments, and the state police departments in Massachusetts, Maine, New Hampshire, and Rhode Island. On September 19, 1997, the Boston Joint Terrorism Task Force split off from the New England Terrorism Task Force and became its own entity. Five years later, on November 7, 2003, the Rhode Island JTTF was established, and shortly after that, the New Hampshire, Maine, and Western Massachusetts JTTFs were created. In 2011, FBI Boston opened the nation's first airport-based JTTF office at Logan International Airport. In total, FBI Boston sponsors five JTTFs in our area of responsibility.

JTTFs gather trained investigators, intelligence analysts, linguists, and tactical experts from federal, state, local, territorial, and tribal law enforcement and intelligence agencies. Task force members share intelligence and investigative leads and respond to threats and incidents.

"Every day, FBI Boston's Joint Terrorism Task Forces are working fervently to detect, disrupt, and dismantle extremist plots before they happen because in today's dynamic threat environment, no one agency can do it alone," said James Crowley, Acting Special Agent in Charge of the FBI Boston Division. "All our partners bring their unique skills, perspectives, and expertise to these teams and work with to support ISIS, specifically, us and our private sector and community partners to keep our communities safe. We thank them for their dedication to this important mission." The FBI's JTTF model dates to 1979, when the New York Police Department and the FBI's New York Field Office created a joint task force to tackle violent bank robberies. They initiated the model in 1980, when terrorist bombings, bomb threats, and other violence plagued the city. Following the 9/11 attacks, FBI leadership directed all FBI field offices to establish a JTTF. Additionally, the FBI established a National Joint Terrorism Task Force to support the local task forces in June of 2002. The NJTTF at FBI Headquarters

communication, enhances coordination, and cooperation from partner agencies.

JTTFs have disrupted dozens of plots in the last four decades, including a plan to attack millennial celebrations in Los Angeles in 2000, a plan to detonate a car bomb in Times Square in New York in 2010, and plans to sow chaos in Baltimore, Maryland in 2022 and 2023 by destroying energy facilities.

The FBI Boston Division counts numerous disruptions of its own, including:

• a plot by Tarek Mehanna from Sudbury, Massachusetts to provide material support to terrorists. In 2012, Mehanna was sentenced to 17 years in federal prison following an eight-week trial where he was convicted of conspiracy to provide material support to Al Qaeda, providing material support to terrorists, conspiracy to commit murder in a foreign country, conspiracy to make false statements to the FBI, and two counts of making false statements. According to testimony at trial, Mehanna and his co-conspirators discussed their desire to participate in violent jihad against American interests and their desire to die on the battlefield.

• Rezwan Ferdaus from Ashland, Massachusetts, was sentenced to 17 years in federal prison on November 1, 2012 for plotting an attack on the Pentagon and U.S. Capitol, and for attempting to provide detonation devices to terrorists.

• David Wright, of Everett, Massachusetts, was sentenced to 30 years in prison on September 29, 2020, after a federal jury convicted him of conspiring to murder U.S. citizens, including police, on behalf of the Islamic State of Iraq & Syria (ISIS). Shortly after, Nicholas Rovinski, of Warwick, Rhode Island, was sentenced to 15 years in prison for conspiring with Wright and Usaamah Abdullah Rahim (now deceased) to commit acts of terrorism to behead Americans and kill police. • Alexander Ciccolo, of Adams, Massachusetts, was arrested by FBI Boston's Western Massachusetts JTTF on July 4, 2015, for plotting to engage in ISIS- inspired terrorist activity. He was sentenced to 20 years in prison after admitting to providing material support to a foreign terrorist organization, attempting to use weapons of mass destruction, felony possession of firearms, and assaulting a nurse during a jail intake process by use of a deadly weapon causing bodily injury. • Edward McLarnon, of Malden, Massachusetts, was sentenced to 25 years in federal prison on May 16, 2018 for buying explosives and firearms with the intent to

murder a federal judge, a former Massachusetts Attorney General, and his ex-wife's husband.

 Xavier Pelkey, of Waterville, Maine, was arrested by FBI Boston's Maine JTTF and later admitted to self-radicalizing, pledging loyalty to ISIS, and conspiring with two minors to commit a mass shooting at a mosque in Illinois. He was sentenced to 15 years in federal prison on November 6, 2023.

JTTFs are also among the first responders to arrive at the scenes of horrific violence – whether they are terror-based or not - and lead the investigations of terrorist incidents.

Among the cases Boston's JTTF has investigated are:

• the 9/11 attacks, given that two of the hijacked flights - American Airlines Flight 11 and United Airlines 175, both of which were deliberately crashed into the World Trade Center - originated from Logan International Airport in Boston. Additionally, Mohammed Atta, the ringleader of the hijackers, had traveled to Logan Airport via a connecting flight from Portland, Maine.

• Richard Reid attempted to destroy American Airlines Flight 63 as it traveled from Paris to Miami in December 2001. Alert passengers thwarted his attempts to ignite a bomb in his shoe, and the flight was diverted to Logan International Airport where he was taken into custody. In January 2003, Reid was found guilty of terrorism and sentenced to life in prison.

• Two self-radicalized brothers, Tamerlan and Dzhokhar Tsarnaev, executed the largest terrorist attack on U.S. soil since 9/11 at the finish line of the Boston Marathon. They detonated two powerful explosives, killing three people and injuring more than 500 others. Days later, on April 18, 2013, the brothers-armed with five IEDs, a Ruger P95 semi-automatic handgun, ammunition, a machete, and a hunting knife-drove their Honda Civic to the Massachusetts Institute of Technology (MIT) campus, where they shot and killed MIT

Police Officer Sean Collier and attempted to steal his service weapon. Following a manhunt that culminated in a shoot-out with police in Watertown, Tamerlan Tsarnaev was killed, and his younger brother Dzhokhar was taken into custody after hiding out in a boat. He was charged with use of a weapon of mass destruction resulting in death and conspiracy along with 29 additional terrorism related charges. Tsarnaev was convicted and formally sentenced to death in June 2015. He is currently appealing that sentence.







Sign language

For professional trainers - those who work with service dogs; first responders handling K9 partners trained to detect guns, bombs, drugs, or find criminals; or people like us out for a walk with our dog – hand signals, gestures, and body language can be more effective than repeating words over and over to get a dog to perform. It's time we all considered using canine language to communicate with our dogs. When dogs interact with one another, you'll notice a lot of body language and rituals. At a distance, canines will begin signaling with their stance, the position and movement of their ears and tail, and their facial expression. You might hear an occasional bark, and during friendly play, you might hear some rumbles and play

growls. But, for the most ing high-fives and shaking part, dogs communicate non-verbally.

Basic Sign Language Debby McMullen, CDBC, writing for Whole Dog Journal, wrote, "When dogs know both hand signals and verbal cues, they are far more likely to respond to the hand signal

hands can add a playful aspect to a training program. American Sign Language

(ASL) It is relatively common to teach a dog to respond to American Sign Language (ASL) if the dog or a family member is deaf or has hearing loss. The existence of a language spoken with hands and facial expressions can be helpful to those who want to have their own set of hand signals for their dog. The National Institutes of Health defines ASL as, "... a complete, natural language that has the same linguistic properties as spoken languages, with grammar that differs from English." The combination of manual and non-manual features parallels natural canine communication skills.



than a verbal cue."

She suggested a list of hand signals you could consider using to communicate with your dog. Among those are "Sit," "Down," "Touch," "Wait," "By Me," "Can I Have That?" (Her name for "Drop It") "Here Here" (means come to me) and one of our favorites, "All Done," indicated with "Jazz Hands," for when we are finished with training or giving treats.

Once you have the basics down, you can add some signs for tasks that are fun for both of you. Teach-

"High-five" is fun and adorable. However, other hand signals are more important.

Check out the ASL signs for love, brush teeth, wonderful, snuggle, come, and go to find signs for a few

things you may want to communicate to your furry friend. Be sure to use appropriate facial expressions and body language, as your dog uses those to understand you.

What's more, according to Dr. Roy Hamilton, MD, trustee of the McKnight Brain Research Foundation. "Learning a new language can be immensely helpful for cognitive health, particularly as we age. This is because language learning engages a wide range of complex cognitive abilities, including memory, attention, and problem-solving, which can help to create and strengthen connections in the brain." It's a win-win!

Short and Sweet

Finally, make any words or sounds you use along with the sign language short and sweet. Be aware that to your dog, "Come over here right now" is translated as "yadda, yadda, yadda" or "blah, blah, blah." As far as your dog is concerned, you sound like a chattering chipmunk with an occasional word like "SIT!, GOOD GIRL!, or NO!" popping up here and there. The combination of the sign language they know and a simple, consistently used word will ensure they understand you.
