Municipal election set for Tuesday, Nov. 4

Polls will be open for the municipal election in Chelsea on Tuesday, Nov. 4 from 7 a.m. to 8 p.m.

There are several contested races for city council and school committee in this year's election.

In the city council atlarge race, there are five candidates for three positions. Joining incumbent atlarge councilors Leo Robinson, Kelly Garcia, and Roberto Jimenez-Rivera on the ballot are Nicholas Gregoretti and Yesenia Alfaro.

District 1 Councilor Todd Taylor is facing a challenge from Christian DeJesus Franco. In District 2, incumbent Melinda Vega is being challenged by Deron Hines.

In District 4, incumbent councilor Tanairi Garcia is being challenged by Marnie MacAlpine, while in District 8, incumbent Calvin Brown is being challenged by Marcezi Kotoni.

Council to vote on split tax rate

The city council is scheduled to hold its tax classification hearing and to vote on a split residential/commercial tax rate and a residential tax exemption at its meeting on Monday, Nov.

Traditionally, the council has approved a 175 percent tax shift to commercial and

industrial properties. In recent years, the council has also approved a 35 percent residential exemption, the biggest exemption allowed by state law.

The greater increase in the tax rate for commercial and industrial properties means that the greater burden of the tax levy will fall

Council looks to help downtown businesses

The city council is continuing to look at ways to help small businesses in the downtown that were affected by the recent Broadway

reconstruction project. At last week's meeting, District 7 Councilor Manuel Teshe requested an update on a motion he previously made to double the number of businesses that receive

funding through the storefront improvement program to help at least ten businesses per year.

"We've had our fair share of listening sessions and heard how much they are struggling and how much they are losing currently," said Teshe. "As I understand, there is money set aside for all the storefront

City manager addresses transportation program, voting

City Manager Fidel Maltez has placed an emphasis on communicating with residents since he took office. Earlier this week, Maltez recorded the latest in his series of public outreach videos to air on Chelsea Community TV. The text of his October video, which focuses on the RC Link transportation program, is below:

Hello, residents of Chelsea. Welcome to Our Community! My name is Fidel Maltez, and it is my honor to serve as your City Man-

We know that there is a transportation gap in Chelsea and Revere that makes it difficult for residents and visitors to travel within and

between our two communities and access critical services, jobs, and essential destinations.

Today, we want to share some big news with you: the Cities of Chelsea and Revere have teamed up to make it easier for all of us to get around by launching RC Link, a new on-demand transportation service serving our communities!

This service improves transit access for our residents and visitors, particularly in areas where public transportation options are limited.

One of the most important features of RC Link is that it is affordable, especially compared to traditional on-demand services. Each ride costs only \$2, and

rides are even more affordable for students, seniors, riders with disabilities, and income-eligible members of our community.

We encourage you to give RC Link a try – take a ride to Market Basket, or to go shopping downtown Broadway, visit Rumeny Marsh Reservation, or walk Revere Beach, with this new program you can visit anywhere you want within our two communities.

Most importantly, it is easy to use. Anyone in Chelsea or Revere can book an on-demand ride through the RC Link app or by calling 339-331-1995. Service is available Monday to Friday, from 7 a.m. to 7 p.m. RC Link gives you a pickup destination, and you will

walk to meet your driver. From there, you are off to your destination.

Beyond the obvious perks of affordability and on-demand service, using RC Link means you can leave your car at home, reducing traffic congestion and freeing up parking spaces in high-traffic areas.

I'm also hopeful that having this new, affordable way to get around Chelsea will help increase voter turnout for our local election on November 4, 2025.

This is an important election - one that will determine who will serve on the Chelsea City Council and School Committee in 2026

Several key election deadlines are approaching, and perhaps the most important is the last day to register to vote, which is Saturday, October 25.

You have until 5 p.m. on the 25th to register in person at the City Clerk's Office, or, if you prefer to register online, you have until midnight.



on those properties.

With a 35 percent residential exemption, the residential tax rate is expected to be \$11.49 per \$1,000 of valuation for FY26, a slight decrease from the FY25 rate of \$11.51, according to Deputy City Manager for Finance Michael Mason. The commercial tax rate is expected to come in at \$23.79 per \$1,000, down from the FY25 rate of \$24.03.

Although the tax rate

is dropping, due to the increase in valuation for properties, it does not necessarily mean that tax bills will be going down. Mason said there will be

moderate to non-existent increases in the property tax bills for residents who own one- to three-family homes and condominiums.

From FY25 to FY26, the average value of single-family homes condominiums have in-

Two-family homes have increased on average by 2.6 percent, three-family homes by 8.5 percent, apartment buildings of four-plus units by 5.1 percent, commercial properties by 3 percent, and industrial properties by 4.1 percent.

creased by about 5 percent.

According to Mason and Chief Assessor Jim Sullivan, the average monthly bill for a single-family homeowner would increase by a little

over \$10 per month with the residential exemption. The increase for two-family and condo owners would be even lower than that, while the average monthly bill for three-family homeowners would increase by about \$50 per month.

In addition to the residential exemption and the tax rate split, there are also a number of exemptions available for senior citizens and disabled veterans.

grants that are coming in the future. I would like to see that we can move up the timeline a little bit so that more businesses are benefitting from this and hopefully we can help them survive."

Teshe said there are a number of businesses in the downtown that are struggling to survive.

"I would also like to

voice my support for our local businesses," said District 1 Councilor Todd Taylor. "Normally, I don't think it is the role of government to try to help subsidize businesses, but the problem here is specifically the downtown Broadway project that has really impacted these businesses. I think that it is incumbent upon the city to

try to mitigate some of that damage a little bit."

Taylor said he would like to see what can be done within reason to try to mitigate some of those problems that were caused by the city and not the fault of the businesses themselves.

"I'm certainly not in favor of any bailouts of any businesses, but any kind of assistance that is affordable and that we can do I think is appropriate," said Taylor. Teshe also noted that

there have been a number of applications that have come in for grant assistance in conjunction with the city and the chamber of commerce, and that the recipients of those grants will be announced soon.







CHS BOYS SOCCER WINS GBL TITLE

The Chelsea High boys soccer team capped an incredible run over the second half of the season by posting two victories over Greater Boston League (GBL) opponents to overtake Revere and claim the 2025 GBL championship.

The victories, by scores of 5-1 over Medford last Tuesday and 4-0 over Lynn Classical last Thursday, allowed the Red Devils to surpass Revere, which had been seeking to repeat as GBL titlists The teams had entered the week tied for first place with 17 points apiece, but the Patriots dropped their final GBL REACHES STATE contest to Somerville, 6-3, on Thursday, enabling the Red Devils to claim the crown.

Last week's victories that propelled Chelsea to the title capped a remarkable run in which coach Mick Milutinovic's crew have won 10 of their last 12 contests. The Red Devils erased a three-point Revere lead in the standings hanks to their 2-1 win over Revere in a head-to-head meeting and a Revere tie with Medford last week

standings The final

showed Chelsea atop the GBL with a 10-3-1 mark and Revere in second with an 8-3-3 record.

Cheslea was scheduled to wrap up its regular season yesterday (Wednesday) with a non-league contest vs. Brighton.

Milutiniovic and his squad, who punched their ticket for a Journey to the Tourney earlier this season, then will await word of their final seeding and first-round opponent in the upcoming MIAA Division 2 state tournament. The Red Devils presently are ranked 26th in D-2.

CHS GIRLS SOCCER **TOURNEY**

The Chelsea High girls soccer team celebrated Senior Night in appropriate fashion by qualifying for the post-season state tournament with a 7-0 victory over Boston International Monday evening at Chelsea Stadium.

The triumph clinched the first appearance in the state tourney for a CHS girls team since 2017, a major milestone for coach Randy Grajal's girls soccer pro-

Chelsea controlled the game from the opening whistle, moving the ball well, creating consistent opportunities, and capitalizing early. The first half ended with a 3-0 lead, and the momentum continued into the second half as the Lady Red Devils added four more goals to secure the final 7–0 result.

Junior captain Yahira Jovel netted a hat trick and sophomore Emily Rodriguez Rodriguez scored two goals to power the Lady Red Devil offense.

The special win came on Senior Night, in which the team honored its three seniors, Kimberly Estrada Mazariegos, Leslie Salmeron, and Britney Castellanos Ochoa, for their contributions to the CHS girls program.

"This victory showcased teamwork, composure, and execution," said Grajal. "The team is proud of this accomplishment and looks forward to continuing their journey in the upcoming tournament."

Just as impressive as Monday night's win was the team's performance last week against two top Greater Boston League foes, Medford and Lynn Classical, in which the Lady Red Devils earned a pair of ties that moved them within striking distance of qualifying for a Journey to the Tourney.

Last Tuesday, Chelsea hosted Medford, which entered the contest with a 12-0-0 record in the Greater Boston League (and had defeated the Lady Red Devils in their first meeting this season). This time around, however Chelsea matched Medford's intensity from start to finish, resulting in a hard-earned 1-1 draw.

Medford scored first on a penalty kick near the end of the first half, but the Lady Red Devils never backed down. They continued pressing, defending, and creating chances throughout the second half.

In the final minutes of the game, Emily Rodriguez Rodriguez broke through on the left side, cut inside toward the middle, and struck a right-footed shot past the keeper to secure the equalizer for Chelsea.

"The goal energized the entire team and was a reflection of their determination and resilience," said CHS head coach Randy Grajal. "This performance showed the team's heart and

strong work ethic from the opening whistle to the final whistle. Our team proved they can compete with one of the strongest teams in the league and will continue to build on this momentum for the remainder of the regular season and postseason play."

Two days later Grajal's squad made the short trek to Lynn to meet Lynn Classical under the lights at Manning Field and came home with another 1-1 draw.

Chelsea struck early in the ninth minute when a corner kick was deflected and landed near the top of the box, where Katherine Benitez fired a right-footed shot into the back of the Lady Ram net to make it 1–0.

The rest of the half was played end-to-end by both sides, similar to the previous matchup between the teams. Just before halftime, CHS FOOTBALL Lynn Classical brought the HOSTS MINUTEMAN contest back to level off a free kick that slipped past the Chelsea goalkeeper.

The second half remained tightly-contested, with both teams pushing hard for the winning goal, but neither side was able to break the deadlock. Chelsea walked away with a well-earned point, leaving the Lady Devils just one point away from securing a spot postseason — a goal the team has pursued since the start of the season.

"The tie left the team confident, motivated, and ready to take care of business to clinch their postseason opportunity. They have shown all year that they can compete with any team in the league, and they plan to keep proving it as they push toward the tournament," said Grajal.

The Lady Red Devils were scheduled to conclude their regular season with a match vs. O'Bryant High School of Boston yesterday (Wednesday) and then will await the announcement of their final seeding and preliminary round opponent in the MIAA Division 2 state tourney.

BRUINS LACKING CONSISTENCY


There's a lot missing in the current play of the Boston Bruins, which is something of concern the when schedule has them playing a host of games

in just a few days. If you hang your hat on the outcome of the first three games of the season - all wins, your hopes are high, but to follow that with a six-game losing streak, can certainly take the wind out of your sails. The answer is obvious, the Bruins have two very different teams that show up on any given night. Case in point, their ability to beat the Colorado Avalanche last week, handing the Avalanche their first loss in regulation, and then reverting to the one we are seeing lately, which is the one that gets hit with far too many penalties – and now a team who had recently boasted a tight penalty-killing unit, into one that fails miserably. A prime example

of lack of effectiveness was evident in their recent disaster on Monday, where they allowed their division rival Ottawa Senators score four goals

on five power play chances. The lack of discipline has been a constant, making the Bruins one of the most penalized teams in the NHL. Giving their opposition multiple chances per game to put their power play units into the game, eventually has proved to be costly. The loss of defensemen Hampus Lindholm to the Injured Reserve list, and the extensive injury to Jordan Harris, could be a partial reason, but not to the extent shown lately by the blue line corps. Head coach Marco Sturm has resorted to constant line changes, both with his forwards and defenseman, as he seeks

State health officials announce ninth human case of West Nile virus in Massachusetts

The Massachusetts Department of Public Health (DPH) announced the season's ninth human case of West Nile virus (WNV) diagnosed in a man in his 50s with exposure in Middlesex County.

No risk level increases are indicated at this time of year. At the end of October, municipalities at high risk for WNV will be reduced to moderate until there is a hard frost.

"This case is a reminder that WNV infections can occur even in the fall, and we should remain vigilant," said Public Health Commissioner Robbie Goldstein, MD, PhD. "We are now past the peak season for West Nile virus in Massachusetts, but some risk will continue until the first hard frost, and we are still reminding ev-

eryone to continue to take steps to protect themselves from mosquito bites."

The first WNV-positive mosquitoes in the state this year were announced on June 17. There were a total of 451 mosquito samples that tested positive for WNV this season from Barnstable, Berkshire, Bristol, Dukes, Essex, Franklin, Hampden, Middlesex, Norfolk, Plymouth, Suffolk, and Worcester counties. There was also one animal case of WNV this year in a goat.

In addition to WNV, Eastern equine encephalitis (EEE) was detected in mosquitoes in Massachusetts this year. There were 23 EEE-positive mosquito samples and no human or animal cases.

Surveillance information, including case updates, will

continue to be updated as needed and posted online at the Massachusetts Arbovirus Update.

People have an important role to play in protecting themselves and their loved ones from illnesses caused by mosquitoes.

Avoid Mosquito Bites

Apply Insect Repellent when Outdoors. Use a repellent with an EPA-registered ingredient, such as DEET (N,N-diethyl-m-toluamide), permethrin, picaridin (KBR 3023), or oil of lemon eucalyptus (p-menthane-3,8-diol (PMD) or IR3535) according to the instructions on the product label. DEET products should not be used on infants under two months of age and should be used in concentrations of 30 percent or less on older children. Oil of lemon eucalyptus should not be used on children under three years of age.

Be Aware of Peak Mosquito Hours. The hours from dusk to dawn are peak biting times for many mosquitoes. Consider rescheduling outdoor activities that occur during the evening or early morning in areas of high risk.

Clothing Can Help Reduce Mosquito Bites. Wearing long sleeves, long pants and socks when outdoors will help keep mosquitoes away from your skin.

Mosquito-Proof Your Home

Drain Standing Water. Mosquitoes lay their eggs in standing water. Limit the number of places around your home for mosquitoes to breed by draining or discarding items that

hold water. Check rain gut-

ters and drains. Empty unused flowerpots and wading pools and change the water in birdbaths frequently.

Install or Repair Screens. Keep mosquitoes outside by having tightly fitting screens on all windows and doors.

Protect Your Animals

Animal owners should reduce potential mosquito breeding sites on their property by eliminating standing water from containers such as buckets, tires, and wading pools - especially after heavy rains. Water troughs provide excellent mosquito breeding habitats and should be flushed out to reduce mosquitoes near paddock areas. Horse owners should keep horses in indoor stalls at night to reduce their risk of exposure to mosquitoes. Owners should also

speak with their veterinarian about mosquito repellents approved for use in animals and vaccinations to prevent West Nile virus (WNV) and EEE. If an animal is suspected of having WNV or EEE, owners are required to report to the Department of Agricultural Resources, Division of Animal Health by calling 617-626-1795, and to the Department of Public Health by calling 617-983-6800.





Ready to "Fall Back?"

When you change your clocks, check your alarms!

With the end of Daylight Savings Time just around the corner, State Fire Marshal Jon M.

Davine and the Fire Chiefs Association of Massachusetts are reminding residents to check their smoke and carbon monoxide (CO) alarms when they change their clocks.

"Working smoke and CO alarms are your family's first line of defense against an emergency at home," said State Fire Marshal Davine. "As we 'fall back' this weekend, please take a few minutes to be sure you and your loved ones are protected."

Modern smoke and carbon monoxide alarms have the manufacturing date printed on the back of the device. Smoke alarms should be replaced after 10 years, and CO alarms should be replaced according to the manufacturer's instructions – usually 5, 7, or 10 years, depending on the make and model.

Fire officials are especially concerned about expiring smoke alarms because of a 2015 update to the State Fire Code. That update, which remains in effect, requires that replacement smoke alarms in most Massachusetts homes have sealed, 10-year batteries. As a result, the first wave of alarms purchased to comply with the update are nearing the end of their useful lifespan.

State Fire Marshal Davine and the Fire Chiefs Association of Massachusetts offered these tips for residents who are replacing outdated single-station smoke alarms. Following these guidelines will reduce the risk that someone will remove the batteries and place them in another de-

Davine and the Fire Chiefs vice or to disable the alarm Association of Massachusetts are reminding resingular vice or to disable the alarm when it's activated by cooksetts are reminding resingular.

- Choose photoelectric alarms from a well-known, national brand
- Look for the mark of an independent testing lab like UL or Intertek/ETL
- Select alarms with a sealed, long-life battery and a "hush" feature"
- Alarms that meet UL Standard 217, 8th edition or later, use the latest multi-criteria technology to reduce nuisance alarms caused by cooking smoke

If your alarms are less than 10 years old and take alkaline batteries, then put in fresh batteries to be sure you're protected all winter long. And remember to test your smoke and CO alarms once a month to be sure they're working properly.

Heating Season Brings Carbon Monoxide Hazards

Westborough Fire Chief Patrick Purcell, president of the Fire Chiefs Association of Massachusetts, emphasized the importance of working carbon monoxide alarms as we enter the colder months.

"Carbon monoxide is a leading cause of poisoning deaths in the United States, and heating equipment is the main source of carbon monoxide in the home," Chief Purcell said. "We can't see, smell, or taste carbon monoxide. Working CO alarms on every level of your home are the only way to detect this invisible killer."

Massachusetts firefighters encountered carbon monoxide hazards at about 5,000 calls last year, Chief Purcell said.

Create & Practice a Home Escape Plan

"Changes to building construction and furnishings mean we have less time to escape a fire at home than ever before," said State Fire Marshal Davine. "You could have just three minutes to get out safely."

"Working smoke alarms and a practiced home escape plan are among the most fundamental and important tools for surviving a fire," said Chief Purcell. "Be sure everyone in the home knows what to do and where to go when the alarm sounds, including young children, older adults, and persons with disabilities."

Fire officials recommend planning two ways out of the building, the apartment, and each room if possible. Be sure to select a family meeting spot a safe distance from the building.

Senior SAFE

Adults over 65 are at disproportionate risk of death or serious injury in a fire, especially if they live in oneor two-family homes. Hundreds of fire departments across Massachusetts have grant-funded Senior SAFE programs that may provide assistance with smoke and CO alarms. Seniors who need help installing, testing, or maintaining their alarms should contact their local fire department or senior center for assistance.





CITY PAWS

Special spot

We were walking home from lunch recently when we crossed paths with a delightful Husky. She walked right up to us while we were asking her guardian if we could say hello. The woman told us it was fine, and this dog loved scratches under the chin.

Do you know dogs who have a special spot that they are happy to have scratched or patted? Dogs may choose different people to deliver different types of attention. Our Poppy runs to Ed for belly rubs, but to Penny for circular massages of her ears and back.

Usual Spots

Some places where dogs react to touch with great pleasure contain sensitive nerves and sensory neurons, known as touch receptors, according to Whole Dog Magazine writer Joan Merriam. "Not to go too Sandy Scientific on you, but these

touch receptors travel along sensory nerves that connect to neurons in the spinal cord, then to the thalamus, and finally to the somatosensory cortex of the brain, which in turn triggers the release of oxytocin. All this happens in the flutter of an eyelash: the only thing we're aware of is that our dog goes into a state of semi-bliss the moment we start rubbing her belly.

Oxytocin release is also true of dogs' very sensitive ears. Consider providing gentle scratches to places where the dog can't reach. Perhaps this is why so many dogs welcome a soft scratch to the base of their tail or under their collar.

Massage

When we consider ways to help our dogs who are frightened, injured, or showing the effects of aging, we may not think of massage. Today, the professionals at major animal hospitals, like the MSPCA's Angell

Animal Medical Center, are including massage therapy as part of their rehabilitation services. While discussing treatment for your pet, ask your vet if there is any sort of massage you could do to help with healing.

You can also use the time you spend petting or massaging your dog as a body check-up. Our Westies have had skin problems, and we would find any hot spots or breakouts during a good rubdown.

Tellinton Ttouch

Over the years, we've used a special kind of massage called Tellington Ttouch on our own dogs and with some of the skittish rescue pups we have fostered. Mardi Richmond described the classic TTouch massage in an article in Whole Dog Journal, "... your fingers are slightly curved and you use the pads of your fingers to create the circles." She has found this "particularly use-





ful for anxious dogs." You can take training for this practice online or in-person classes.

Remember, petting, massage, or touch therapy are all good ideas if you and your dog both enjoy the experience. Some dogs melt into your lap or snuggle up beside you and soak up strokes like arid soil in a gentle rain. Others squirm and can't wait to get away and get on with more interesting things.

A sign that a person is a dog lover is when their hands unconsciously begin to stroke, pat, and gently scratch a dog sitting beside them. Did you know that petting a dog can lower heart rate and blood pressure, release happy hormones, and generally relax both the canine and human partners? It's a win-win way to spend time together.
