Chelsea **Viaduct** contract approved

The state Department of Transportation (MassDOT) has approved the contract for construction on the Chelsea Viaduct project, with the low bidder being Skanska McCourt at \$169.37 million, some 3 percent below estimates for the massive rebuild-

A key part of the scope of work identified in the documents includes keeping the Arlington Street on-ramp, an entryway that had been considered for possible removal.

The project was bid out in July, and a Notice to Proceed is expected in January, with substructure repairs starting shortly after that and into the spring of 2020.

The Chelsea Viaduct is the elevated highway that runs from the County Road overpass to just beyond the 4th Street off ramp. The project has been in the planning stages for more than a month.

The scope of the project includes repairing and retrofitting the superstructure underneath the viaduct. That will take the rusted steel beams and retrofit them with new concrete structures that will be decorated with murals.

That work is expected to begin in the early months of 2019 and will proceed through the spring of 2020 - lasting more than a year.

Condo owners organize in protest of 'exclusive' water discount program

A new and irate constituency of condo owners has arisen in response to the Water Discount program championed by Councilor Giovanni Recupero and voted on by the City Council Sept. 24 – a proposal that excludes condo owners from the owner-occupied wa-

Recupero proposed the measure in September, after many years of discussing it and proposing it in other forms, to find that it had support and the votes to pass. After a challenge by Councilor Roy Avellaneda last week, the measure stood.

It is to go into effect on July 1, 2019 with the new water rates.

But what it might have lacked in votes on the Council has not deterred the momentum that has grown among those in the City who own condos. Because condo owners don't have separate water meters in their units, they are excluded from participating in the program along with absentee landlords.

That has ignited a base that continues to protest the move, and has spoken out this week in letters to the newspaper that

Planning Board okays McDonald's rebuild project

The golden arches on Revere Beach Parkway are going to shine a little brighter.

Tuesday night, the Planning Board approved a special permit allowing for the demolition and rebuild of the Mc-Donald's at 170 Revere Beach Parkway.

The updated fast food restaurant will be larger than the current building and will feature a double drive-through lane, according to project engineer William Lucas. There will also be fewer parking spots and more green space on the property.

"McDonald's is going through a nationwide rebranding program at all its restaurants," said Lucas.

In many locations, that means major renovations. But in Chelsea, Lucas said the demolition and rebuild of the restaurant will help improve accessibility inside and outside the restaurant.

"This will bring the restaurant into compliance and improve operations," he said. "They are implementing a side-by-side drive-through instead of the single file line."

The current drive-through lane is parallel to Washington Avenue, while the new window will face Revere Beach Parkway. The size of

the building itself is slated to increase from 3,500 to 4,400 square feet, and the number of parking spaces will decrease from 65 to 32.

Planning Board Chairman Tuck Willis asked how long the demolition and rebuild will take once work gets underway.

"Generally, it gets done in less than 60 days," said Lucas.

Board member Todd Taylor said he did have some concerns about the project if the construction affects Washington Avenue.

"The traffic there is such a bad problem," said Taylor. "That is the main way out of Prattville, and in the mornings, there is a huge backup and people cannot get out of the neighborhood."


Other than the McDonald's vote, it was a fairly lowkey evening for the Planning Board, as it approved special permits to convert several single-family homes to multi-family units.

The massive, 630-unit Forbes Street project was continued to the board's Nov. 27 meeting.

The most excitement during the meeting came during a thunderstorm, when several board members were startled during an especially close and loud boomer.

Three reasons to vote 'No' on Question 1

Because I'm a nurse, and I work in a hospital, I'm asked every day how I feel about Question 1. I'm beyond concerned. I'm scared—for patients and nurses-and I'm voting "No." Question 1 highlights an important topic, but it is a dangerous approach to something as vital as our healthcare.

Question 1 is confusing. There are bedside nurses for and bedside nurses against. Everyone on both sides wants quality care and safe staffing. The difference lies in how we make that happen. Question 1 proposes fixed nurse-to-patient staffing ratios for every type of patient care unit (e.g., General Medical, Emergency). These exact same ratios would be required by law throughout every hospital in Massachusetts, at all times and under all cir-

cumstances. If the prescribed of nurses with a government reratios aren't met, a fine of up to \$25,000 would be assessed per incident, per day.

It sounds simple. A closer look reveals many unintended consequences.

First, nurses should make decisions about patient care, not the government. On the same care unit, a patient just out of surgery has very different needs than a patient who is stable and sitting up waiting for a ride home. Yet ratios prescribe the same level of care. It doesn't make sense. Nurses at the bedside are uniquely-skilled and highly trained to manage each patient's individual needs, allocate resources, make judgment calls, and triage as needed. They need the flexibility to adjust the plan of care in the moment, based on the changing needs of the patient. Caregiving-by-ratio would replace the

judgment and decision-making

quirement.

Second, there's a hidden domino effect: Patients would have trouble accessing the care they need when they need it. There are not enough qualified nurses within Massachusetts to meet these arbitrary staffing ratios. Without enough nurses to meet these mandated ratios by law—care units could not accept more patients. Beds would have to lie empty. Patients in the ER would have long waits until a bed opened up. Outside the ER, EMTs would have to wait with their patients until space inside became available. The national shortage of behavioral health and ER nurses makes this all worse. While we grapple with the current opioid crisis, an estimated 1,000 behavioral health beds would close; these hospitals currently have waiting lists.

Third, while we can't put a

price on safety, there is a cost. If passed, the estimated price tag on Question 1 is upwards of \$1 billion—every year. Question 1 is unfunded; there is no identified way of paying for it. So this cost will be passed on to all of us as patients, either through higher insurance premiums, increased medical bills, and/or reduced services.

There is more that concerns me about Question 1, much more. If passed, it has the potential to dismantle our healthcare system as we know it. Why would we ever experiment with something that puts us all at risk? Please join me in voting "No" on Question 1.

The decision is blatantly discriminatory To the Editor:

On September 24, 2018 the Chelsea City Council voted, 7-3, with one councilor absent, to give a 10% discount on water and sewer bills for owner-occupied single, two-family, or three-family homes, and to owner-occupied condominiums with an individual water meters; the new rates are to be implemented by July 1, 2019. In practical terms, this order excludes condominiums. It also means that EVERYONE ELSE IN CHELSEA – as many as 1,861 condominiums (even those that are owner-occupied) ALL renters, ALL business owners, ALL places of worship, ALL charities—will be EXCLUDED from this dis-

Chelsea water and sewer rates are increasing significantly, and the Council's vote means that those renters, businesses, and 1,861 condos are going to subsidize a discount

for 625 single-family households (owner-occupied) and 1,149 two- and three-family households (owner-occupied with tenants in other units).

This decision is blatantly discriminatory as it creates separate classes of homeownership in Chelsea, and privileges residents who have the financial capital to buy and own single or multi-family homes – all at the expense of, among others, condo owners who are also stakeholders in the community, and deserve the same consideration as other homeowners.

This policy hurts renters, whose exempt landlords will pass on the water and sewer rate increases by increasing their rent or cutting back on other services. This policy hurts charities, places of worship, and medical facilities, which are all exempt from this discount. This policy hurts business owners, who will pass on these costs to their local customers. Simply put, this is a poorly conceived and exclusionary policy that was rushed to a vote without any meaningful discussion or community input, and that benefits the few at the expense of the many.

We, the undersigned Chelsea residents, are opposed to this rebate, and respectfully ask the Chelsea City Council to reverse its vote before the rebate goes into effect and send the matter to a sub-committee on conference. There needs to be meaningful, deliberative inquiry and debate on the subject, and substantive community input.

decry the program and, potentially, others like it that could come down the road.

"Chelsea water and sewer rates are increasing significantly, and the Council's vote means that those renters, businesses, and 1,861 condos are going to subsidize a discount for 625 owner-occupied, single-family households and 1,149 two- and three-family households," read a letter written by Sharlene McLean and signed by numerous condo and homeowners. "This

decision is blatantly discriminatory as it creates separate classes of homeownership in Chelsea, and privileges residents who have the financial capital to buy and own single or multi-family homes – all at the expense of, among others, condo owners who are also stakeholders in the community, and deserve the same consideration as other homeowners."

The condo owners wrote that the policy will hurt the entire community. For example,

they said houses of worship are not allowed to participate, and neither are businesses.

"Simply put, this is a poorly conceived and exclusionary policy that was rushed to a vote without any meaningful discussion or community input, and that benefits the few at the expense of the many," they wrote.

The new constituency of condo owners asked that the Council repeal its vote before the new rates go into effect.

That will be followed by replacement of the superstructure, which is the decking that the cars and road operate upon. That will be replaced primarily through a pre-fabricated bridge pieces that will be lifted into place and secured. Only two small pieces of the Viaduct will require traditional repair techniques. That will be over the railroad tracks and by the 4th Street off ramp.

There will be no traffic impacts on Route 1 during peak travel times. All work will be performed between 10 p.m. and 5 a.m. on the substructure rehabilitation.

In the fall of 2020, the superstructure replacement will feature some traffic impacts, as they move three lanes into two lanes southbound and two lanes northbound. There will also be interim ramp closures at that time and some parking impacts as well.

As a part of the mitigation






A before and after view of the substructure repairs to the Chelsea Viaduct, going from rusted steel to a mural.

for the community, a new community parking lot will be constructed below the Viaduct to help with downtown parking. There will also be improved lighting and a solid snow fence built around portions of the Viaduct.

Completion is expected in 2021.

MassDOT officials said

they are in the process of assembling a Chelsea Task Force that will analyze public transit, vehicular travel and other travel options throughout construction and work to ensure reliable transportation for all. More is expected on that Task Force in the coming months.

BOYS SOCCER WINS TWO TO CLINCH CAC LARGE DIVISION TITLE

The Chelsea High boys soccer team won both of its games this past week against opponents from the Commonwealth Athletic Conference to clinch the title for the CAC Large Division.

Coach Mick Milutinovic's Red Devils now stand at a near-perfect 12-0-2 on the season with just two contests remaining, one with non-league archrival Everett and the other with Greater Lawrence.

The twins wins against Greater Lowell and Lynn Tech earned Chelsea revenge of a sort, inasmuch as the Red Devils' lone blemishes on their season's record came via ties with both of those CAC

In last Thursday's 3-1 triumph over Greater Lowell at Highland Park, Chelsea got on the board early thanks to an own goal by a GL defender, who inadvertently sliced the ball into his own net.

Greater Lowell bounced back five minutes later with a goal (into the Chelsea net) to bring matters back to level at 1-1, but Gabriel Contreras put the Red Devils ahead to stay with five minutes left in the first half. Carlos Ayala earned the assist when he brought down a long ball from the Chelsea back while in traffic, settled the ball for a moment, and then laid off a nice pass to a breaking Contreras.

The contest remained deadlocked at 2-1 until the Red Devils finally achieved some breathing room with two minutes left in the game on a goal by Brainer Padilla. Brainer was the beneficiary of a superb effort by Gabriel Garcia, who took a GL defender 1-on-1 deep into the box and then dropped a pass back to Padilla, who put it home for the clinching score.

"Gabriel does not score a lot of goals, but he generates a lot of our offense," said CHS assistant coach Evan Protasowicki, "so it was nice to have him get the assist for his ef-

The Red Devils avenged the second of their two ties this season with a 2-0 victory over the Lynn Tech Tigers Tuesday afternoon in a contest that was halted for 30 minutes because of nearby thunder.

Gabriel Contreras gave Chelsea a 1-0 lead at the 24 minute mark. Gabriel settled a long ball from his brother, Angel (who plays in the CHS backfield), with his chest, just outside the box, and then delivered a powerful strike that broke through the Tech keeper's hands.

With two minutes left in the half, Delmer Romero, Chelsea's leading scorer who had sat out the Greater Lowell game with a knee sprain, beat a Tech defender with a 1-on-1 move inside the box and then laid a pass back to Carlos Lopez at the top of the box. Carlos cleanly placed the ball into the back of the Tech net for a 2-0 Chelsea lead at the intermission.

The Chelsea defense and the Red Devils' ace keeper, captain Roberto Portillo, played flawlessly the rest of the way to finish with a clean sheet.

"Tech is the most dangerous team we play because of the speed of their top players," said Protasowicki. "You cannot afford to make a mistake when you play them. Our captain, Jose Gutierrez, and the rest of the defense really stepped up to shut them down."




