## **Smart Growth Zoning wins** unanimous **Council** approval

Much of the public discussion over the Smart Growth overlay district for Central Avenue over the past several months has focused on the technical aspects of the zoning ordinance.

But Monday night, as the City Council unanimously approved the Smart Growth zoning - which will pave the way for the Innes Development project to move closer to becoming a reality - much of the talk focused on the human and community benefits of that de-

As the final vote was made official, cheers and applause were heard from Innes residents, project development team members, and even City Planning and Development Director John DePriest.

"This will allow for new homes that all the residents of Chelsea can be proud to call their own," said Ronnie Slamin, the project director for Corcoran, the developer behind the Innes Street/ Central Avenue housing redevelopment plan.

The special zoning designation, allows the mixed-income project to have its own,

## Licensing **Commission** disciplines several establishments

If one is looking to hit the local bars this Cinco de Mayo, the options are going to be a little more limited than usual.

At its March 7 meeting, the Licensing Commission disciplined two local restaurants for a variety of infractions that will result in them losing their liquor licenses for the Cinco de Mayo weekend on May 4 and 5. (The restaurant Cinco de Mayo in Chelsea was not disciplined or called to the Commission).

In addition to losing its liquor license for that weekend, the Commission voted to roll back Acapulco's hours of operation indefinitely, forcing the Fifth Street establishment to close at 11 p.m. instead of

The Acapulco punishment stems from an incident last November when a security worker at the restaurant struck a customer over the head with a police baton.

The Commission also enforced an hours rollback from 1 a.m. to 11 p.m. - along with the weekend suspension - for Bar La Cueva at 802 Broadway. That punishment was enforced for an incident where several patrons were overserved, as well as for past concerns about noise and unruly patrons at the bar.

In addition, Commission member James Guido requested a hearing next month

# CHS junior wins national title

Bobby Goss, Eddie Richard, Richard Bradley Steve DePaulo, Katrina Hill, Drenda Carroll, Nicole Hancock and the late Anthony "Chubby" Tiro" are among the best to ever compete in the Chelsea High track programs.

Stephanie Simon has joined that illustrious group - and she's only a junior.

Simon completed her indoor track campaign with an unprecedented accomplishment: winning the long jump championship in the Emerging Elite Division at the 2019 on." New Balance Nationals that was held in New York City.

Simon soared to victory with a career-best jump of 18 feet, 10.75 inches, remarkably eclipsing her previous best by seven inches.

CHS track coach Cesar

Hernandez was not surprised by Simon's victory or the dramatic way in which she achieved it.

"Stephanie had jumped 17-9 as her best in her first three attempts," said Hernandez. "In the final, she took off to 18-10. I knew she had it in

Hernandez and CHS Director of Athletics Amanda Alpert watched the drama unfold at the Nationals.

"It was exciting to watch the long jump competition," said Hernandez. "It feels good to coach a national champi-

tional championships as a women's professional football player and coach, said the whole scene at Nationals was "amazing."

"To hear and see the number that Stephanie posted was amazing," said Alpert. "It was just about her hitting the board right and she did."

Alpert said Simon's competitiveness and work ethic set the foundation to victory.

"Stephanie is a rarely seen combination of hard work, dedication and pure talent," said Alpert. "She has put in so much time in to making herself better both physically and mentally. Her dedication to the sport and her craft is amazing, but a lot of that comes from the Chelsea track coaching staff. They work to instill the importance of hard work and dedication because that is what is more important and will help you succeed after high school."

Alpert expounded on the Chelsea coaches' contributions to the Stephanie Simon success story.

# Chelsea's Real Estate **Resurgence Continues**

## Bowen, Castillo set to unveil Parker Place condos

Chelsea real estate agent Jeffrey Bowen said all the hard work by city officials over the past 20 years is pay-

"Chelsea is booming," says Bowen. "City Managers Jay Ash and Tom Ambroino, the city councilors, and the community have brought it back to where we are now. Chelsea is the No. 1 gateway city in America with the lowest price-per-foot next to a major metropolitan city (Boston)."

Bowen knows much the city's resurgence and the booming real estate scene. He is currently marketing his third major project, Parker Place, 12 new luxury condominiums at the corner of Parker Street and Spencer Avenue. The developer for the three projects has been Jason Roback of Roback Real Estate.

"Jason prides himself in bringing value and quality to the future residents of Chelsea," credited Bowen.

Bowen and his partner, Sandra Castillo, of ERA Russell Realty Group, will host an open house each Saturday and Sunday (12-2 p.m.) at Parker Place, which is already draw-



ing significant interest among prospective buyers.

Bowen's previous successes span the city, notably the Beacon Condominiums (81 Broadway) and the Thomas Martin Lofts (204 Spencer Ave.)

Parker Place, located at 87 Parker St, is a seven-story building featuring 12 units: 11 two-bed, two-bath, one two-bed, one-bath. Five of the units have garage parking, seven have outdoor spots. Out of the 11 two-bed, two-bath units, one is an affordable unit for medium-income residents (price to be determined by the City of Chelsea).

According to Bowen and Castillo, the prices at Parker Place range from \$449,000 to

"Each condo has air-conditioning, maple hardwood

flooring, custom kitchens, and stainless-steel appliances," said Bowen. "This in an elevator building. Four of the units have roof decks. Eight of the units have balconies.'

Bowen said the area has become one of the hottest in the greater Boston real estate market.

"You have the DaVinci Lofts (960 Broadway), the Industrie Lofts (950 Broadway), the Spencer Lofts (60 Dudley St.), the Keen Lofts (220 Spencer Ave.), and the Thomas Martin Lofts (204 Spencer Ave.),' said Bowen.

And the boon is continuing, with the Chelsea Zoning Board's approval Tuesday night of the Forbes Development that will consist of 590 units.

## A good time to buy

There is no time like the present to invest in Chelsea, according to Bowen.

"Condominium prices are 25-50 percent higher a mile or two away in East Boston and Charlestown," said Bowen. "Downtown Boston and the Seaport District (South Boston) is double and triple. Chelsea is still very afford-

# Forbes Park plan approved by ZBA

The Forbes Park development proposal, with more than 500 residential units proposed for the former industrial campus, has been approved by the City's Zoning Board of Appeals (ZBA) after four years and two major re-designs.

The final iteration of the project includes 590 units of housing, with 60 percent of those units being condos for sale and 59 units being affordable to a range of incomes. There are also 1.6 parking spaces per unit, or 963 spaces. The project also boasts a major public access area to the waterfront of the Chelsea Creek and Mill Creek. The current project also has a very small amount of retail and office uses, with both totaling below 20,000 sq. ft.

The project, though still very large, was scaled back from the developer's (YIHE Forbes of China) original proposal in 2015. That proposal featured skyscrapers about 21 stories tall and more

than 1,000 units of housing accompanied by large office spaces and large hotels. It was rejected informally and the company eventually withdrew during a ZBA meeting that went past midnight.

The news of Tuesday's approval of the new plan was viewed with mixed results by most, including those who had come to support the project, including City Manager Tom Ambrosino.

"I'm happy with the project even though it's far from perfect," he said. "Given all the concessions made since they first showed up here, I think it's a workable project. There is lots of homeownership, with 60 percent being condos. This is the largest condo project in Chelsea for more than a decade if not longer. They also have really exciting plans for accessing the waterfront along the Chelsea Creek.'

Ambrosino said they also agreed to several affordable housing concessions. Of the

## **Licensing Commission close** to vote on marijuana regulations

With plans to host four recreational marijuana shops already at some phase of readiness in Chelsea, the Licensing Commission is nearing a final addıtıonal rules for those establishments.

On March 7, the Commission continued a public hearing on the regulations, focusing on the topics of application fees, locations of the pot shops, and security.

Commission Chair Mark Rossi said the Commission should be ready to take a final vote on the regulations at its meeting in early April.

The City is limited to four retail marijuana establish-

Those shops will already be vetted heavily before they reach the Licensing Commission for final approval. Other approvals include a host agreement in place from the City and approved by vote on regulations for special the state's Cannabis Control Commission, as well as any necessary approvals from the City's Zoning and Planning

> Rossi said the Licensing Commission will grant the retail pot shop licenses in much the same manner as it does for liquor licenses.

## Accountability and closure in fatal shooting of Pablo Villeda

A Lynn teen, who was originally from Chelsea, pleaded guilty March 7 as his trial was set to begin on charges that he opened fire during a party three years ago, killing 19-year-old Pablo Villeda and injuring six others.

Emanuel Marrero, 19, pleaded guilty to second-degree murder in connection with Pablo Villeda's March 6, 2016, shooting death, as well as six counts of armed assault with intent to murder and related charges for injuries suffered by six other young peo-

Judge Linda Giles imposed the mandatory sentence of life in prison, ordering that he be eligible for parole after 15 years and that his sentences on the non-fatal shootings be served concurrently. Had he chosen to go to trial, the defendant - who was 16 at the time of the homicide – would have faced a first-degree murder charge.

'We accepted this plea because it delivers a significant

measure of accountability for the defendant's actions, which took Pablo's life just as it was ready to begin," District Attorney Rachael Rollins said. "It also considers all the potential outcomes at trial and on appeal, as well as the defendant's age at the time of the homicide. Nothing we do can

special regulations for parking and density and other requirements. It also unlocks \$5 million in state and local funding for the project.

Development Corcoran will assist in developing the 330-unit community on the site of the current housing development. Those units will include the existing 96 public housing units, as well as 40 workforce housing units. The remaining 194 units will be market rate, and with the state and federal grants, will subsidize the replacement of the public housing units.

Overall, the development would have a 41 percent affordable ratio, which is three times as much as what would normally be required by the City and double the state requirements.

For many of the current Innes residents, and for members of the Chelsea Housing Authority, it is a major step forward to replace the current units, which are rundown and decades old.

and decent for our children, elderly, and the disabled," said Melissa Booth, co-president of the Innes Residents Association.

The Smart Growth overlay district will cover the current footprint of the Innes Development, and puts a premium on affordable housing and access to public transportation.

Chelsea Housing Authority (CHA) board member Bertram Taverna said the Innes redevelopment is the kind of opportunity that the City has not seen for decades.

"We are talking about an opportunity for these 96 families, as well as 40 more affordable housing units," said Taverna. "Everybody is invested in this project and wholeheartedly all in."

CHA Executive Director Al Ewing said the redevelopment will give the city the ability to deliver on its promise of providing a home where residents can be proud to live and raise their families.

"This is a win for the City "It is our dream to live in of Chelsea," said District 8 new apartments that are safe Councillor Calvin T. Brown.

"Folks are going to see that Chelsea can do this and other cities are going to do this."

Council President Damali Vidot said it's been a long road for the Innes project to move forward. The Council voted down a project three years ago because prevailing wages for workers wasn't on the table.

With prevailing wages now part of the development proposal, the only major issue that gained any traction over the past several months was, unsurprisingly, parking.

While the smart growth zoning is one major step towards getting shovels in the ground for the project, developers will be back before the Council for approval of a TIF (Tax Increment Financing) tax break for the project. That is expected to come before the Council later in the spring.

Vidot said that parking will be addressed in the TIF.

Corcoran is proposing 226 on-site parking spots, with an option to lease another 50 parking spots nearby.

or two per voting district.

The City ordinance already limits the establishments to three zoning districts -- Industrial, Shopping Center, and Business Highway zones.

By the end of last week's hearing, there was general agreement among the commissioners that there would not be a restriction on how close the pot shops can be to one other.

City Councillor-At-Large Roy Avellaneda agreed that was the right move on the is-

"I would oppose any sort of restriction on the number of feet from one place to another," he said. "We already have zoning in place in the city and we don't need to add another

layer to that; we don't do it for other businesses.'

The Commission also agreed on a \$500 application fee and \$5,000 yearly renewal fee for the marijuana businesses

While there were some questions about the Commission's role in looking at security at the establishments, City Solicitor Cheryl Watson Fisher noted that there are already strong security requirements from the state, and requirements are also written into the host agreements with the prospective businesses.

Commissioner Roseann Bongiovanni said she would still like to look at the host agreements to see how they address security before taking

the final vote next month.

"I don't think security is going to be an issue," said Commissioner James Guido, adding it is more likely traffic that could cause some issues.

According to the proposed regulation, the Licensing Commission would not issue a license to anyone who has violated Licensing Commission rules and regulations in the past five years. All licenses are subject to zoning approval and state Cannabis Control Commission approval.

The operating hours for retail shops will be limited to 9 a.m. to 9 p.m., and all signage will have to be approved by the City, according to Fisher.

The attorney for Acapulco said the issue at his client's establishment is systemic of a larger issue in the city, where security at bars is handled by companies that act almost as paramilitary or law enforcement agencies.

commissioners agreed that there is a larger issue that needs to be addressed in the city with bar and liquor establishment security, but noted that Acapulco deserved a more forceful discipline than simply firing its current

"You say security is a problem, but you've had the same company for a decade," Commissioner Roseann Bongiovanni said.

The issues at Bar La Cueva seemed to extend beyond the recent incident where two people were overserved, as several commissioners noted that there have been noise and unruly patron complaints at the bar for years.

In a letter, one neighbor stated that the "karaoke singing by drunks is terribly loud and they overserve their patrons."

John Dodge, the attorney representing the bar, said for the incident in question, his clients acted responsibly and asked the patrons who appeared to be intoxicated to

But Bongiovanni noted that the bar has been a problem in the past, including racking up a 14-day fiquor ficense suspension about two years ago.

"They have been a complete nuisance and annoyance to the neighborhood; you can roll your eyes all you want,

counselor," she said to Dodge.

Both the bars got off relatively easy compared to Fine Mart, a liquor and convenience store at 260 Broadway. The Commission suspended the store's liquor license for a total of six weeks for three offenses, including an incident where an employee struck a woman who was intoxicated in the store, for selling nips after the enactment of the City's nip ban, and for the sale of alcohol to a minor.

City Manager Tom Ambrosino, an ardent supporter of the City's ban on 50 ml bottles of alcohol, said there needs to be consequences for businesses that violate the ordinance.

"The ban has been important in the city's efforts to try to make Broadway a more attractive place to shop and dine," Ambrosino said. "We've spent a lot of money to make it a better place. Having the hip ban in place is an important part of that. "(Fine Mart) has a prominent place in the corridor and has to comply with its license."

percent of the AMI. "That's really deeply affordable and it assures that actual families that live in Chelsea now will be able to afford to live in the complex. That was very important to the City," he said.

The developer also agreed to contribute \$300,000 to the four schools at the Mary C. Burke Complex, which is about two blocks from the Forbes entrance.

That said, not everyone was happy with the news – and in particular was Councillor Joe Perlatonda, who represents the Mill Hill and Forbes area. He said the problem with the Forbes project is the same as it has always been, and that problem is the fact that there is one access point.

In the first iteration, City officials - including Ambrosino - had called for a bridge over the Chelsea Creek to Revere as a second access point to alleviate traffic in the neighborhood. However, this time around that was not made a requirement, and Perlatonda said he was not happy there was a concession made on that point.

"It's a shame that no one has thought about the concessions of the residents that live in our neighborhood," he said. "Right now, with cars parked

on both sides of the street that go into the Forbes site, and what we have to go through every day. Try getting out of your driveway every day; try driving down the street when you have to dodge cars, and then add 963 parking spaces which is 1.6 cars per unit. "The number of affordable units, deeper levels of affordability and preference for Chelsea residents for those units - together with the mitigation for the adjacent neighborhood and the \$300,000 for

Ambrosino said the site is very large, and that did allow the developer to be able to build large numbers of units by right if they chose to do so and could meet the parking requirements. Assistant District Attorney Julie Higgins of the DA's Homicide Unit was prepared to introduce evidence and testimony showing that the defendant brought a .40 caliber handgun to the party, flaunting it to several other attendees. At some point, the evidence would have shown, the defendant confronted the victim and opened fire. Pablo was mortally wounded and six other people were struck, and fortunately survived their injuries. The defendant fled the scene but was identified in the course of an exhaustive investigation by Chelsea Police detectives and the Suffolk County State Police Detective Unit.

The defendant was represented by attorney Richard Chambers.

#### DOWNTOWN FAÇADE **PROGRAM**

Draft ordinances are now before the City Council and Planning Board with recommended changes to signage regulations and new proposed provisions for outdoor dining in the downtown.

The Planning Board will hold a hearing on March 26 to review the ordinances.

The revised signage regulations detail the variety of sign types businesses desire, including creative use of the sign band (that is, the main sign over the business entrance), awnings that include the business name or a descriptor, window graphics, signage for businesses in the upper stories, projecting (sometimes also called blade) signs and sidewalk signs. Chelsea's existing regulations currently limit businesses to just a single sign that is flat on the façade. The proposed ordinances provide a definition for each sign type and address the size and proportion, materials and techniques, and lighting and maintenance for signage.

The goal of the ordinances, along with the companion Broadway Façade Guidelines, is to encourage quality, durable, creative facades in the downtown that reflect the unique character of Chelsea. It seeks to preserve and celebrate the historic architectural design of downtown properties. The Guidelines and the ordinances themselves are intended to be easily understood and enforceable. The ultimate purpose is to make a more attractive and active downtown.

#### **REVALUATION IN** 2020

Pursuant to Massachusetts law, the City of Chelsea is required to conduct a comprehensive revaluation of all property in the City for Fiscal Year 2020, which begins on July 1, 2019. As part of this comprehensive revaluation, the Chelsea Assessor's Office must collect data on properties throughout Calendar Year 2019, including conducting interior inspections on a certain percentage of properties in the City. As a result, some property owners will be receiving letters requesting permission for such an interior inspection. When an assessor or a contractor working on behalf of the City to conduct such an inspection actually visits the property, you should ask to see their City issued ID. An assessor will ask only property-related questions. However, the assessor or contractor will never ask about personal information, immigration status, mortgage status, social security number or credit card information during an inspection. It is the City's goal to ensure that all properties are assessed fairly and equitably, so we ask for your cooperation during this effort.



## HANDS-FREE DRIVING **MAKES SENSE**

Recent statistics indicate that the single-biggest cause of motor vehicle accidents these days can be attributed generally to what is known as "distracted driving."

According to some reports, more Americans now are killed on our roads because of distracted driving than from driving under the influence of drugs or alcohol.

That is why we fully support the legislation recently filed by Gov. Charles Baker that would require all use of a cell phone or other device to be strictly hands-free. It simply is not possible for anyone to keep their eyes on the road while texting, dialing, or reading from an electronic device -- and the epidemic of accidents on our roads is the best evidence of that.

We also support another aspect of Gov. Baker's bill that calls for the non-use of a seat belt as a primary offense, thereby giving police the authority to stop a motorist and issue a civil citation solely for not wearing a seat belt. Under the present law, a person may be cited for a seat belt violation only if the operator has been pulled over for another offense (such as speeding). Massachusetts is fairly unique in this regard, but the governor's bill will bring us into line with the majority of other states.

Another key aspect of the bill would require anyone convicted of a first offense for operating under the influence who applies for a hardship license to use an ignition interlock device for a minimum of six months, and be subject to penalties from the Registry of Motor Vehicles for attempting to drive after drinking or tampering with the device.

In our view, drinking and driving should not be allowed at all. But to the extent that we have a 0.08 threshold, imposing the requirement of an ignition interlock device for first offenders is hardly draconian -- anyone who drinks to that extent and gets behind the wheel of a car clearly has a problem.

Moreover, we are in favor of any additional measures that serve as an added deterrent to drinking and driving and thereby improve public safety.

#### **FORBES PARK** APPROVAL A DISASTER FOR **NEIGHBORS**

Dear Editor,

After speaking out against the Forbes Park site due to parking issues and the flow of traffic it will cause the abutting neighborhoods, I was very upset to see the Zoning Board's approval to build 590 units on the site.

The people in favor were the Collaborative, GreenRoots (which sent a letter with their concessions), councillors who have not met or even been approached by developers YIHE Forbes LLC, and concerned neighbors.

City Manager Tom Ambrosino also supported it, even though back in 2015 he said he would not support the project, but understood something needs to go on the Forbes site. On Tuesday, he supported the project, which I couldn't understand when he and others had stated in the past that if the alternative access problem could not be solved, then any development there will have a

big impact. Ambrosino suggested in the past that an access point using Railroad Street in Revere and crossing over the Mill Creek and into Forbes. That would keep most vehicles out of the Chelsea neighborhood and give exclusive access to the development from major

roadways like Rt. 1, Rt. 1A and the Parkway.

"It's not a long span across the water and it could be expensive but I don't think it is insurmountable," he said in the Chelsea Record in 2015. "You have to address the environmental issues, but if you're investing \$500 million, it could make sense to think about another \$50 million to solve the access problem."

So what changed since then? YIHE Forbes LLC states that there will be two entrances 100 feet apart and could be so close to the abutting residential properties that these neighbors have to put up with, and remember there is still only one way access in and one way access out which still doesn't solve the prob-

the developer is putting in a helicopter pad for quick access out.

There are other alternatives which were brought up by another councillor like the MBTA building a stop to alleviate some of the traffic problems, but then again it comes down to the almighty dollar, and God knows the developers all have to make money,

As we begin the holy season of Lent, this annual time of prayer, fasting and almsgiving affords us the opportunity to be renewed by God's love and mercy as we recommit ourselves to lives of prayer and service to others.

This year, Lent has particular significance for the leadership of the Church at every level, local, national and universal. Recently Pope Francis called bishops from every country in the world to come together at the Vatican for the Summit to Protect Children and Minors. The summit included powerful testimony from survivors of clergy sexual abuse, religious sisters and laypersons who made clear that a meaningful and effective response from the Church is long overdue and of critical importance. I participated in the summit as the President of the Pontifical Commission for Protection of Minors and,

with all present, was deeply impacted by those who addressed us.

Given the depth and seriousness of the crisis and the failures of the leadership of the Church, the expectations for the meeting were high and people are anxious to see concrete results. I left the meeting convinced that no bishop could possibly say that his diocese is not affected by these issues or that this is not a problem in his country and culture. Patience among our people and in the wider community is exhausted and understandably the call is rising for effective action.

A dominant theme at the meeting was the need for an effective reporting mechanism when a Bishop or Cardinal has failed in his duty to protect children or has himself abused children or vulnerable adults. Although I believe an effective set of procedures will be developed by the United States Conference of Catholic Bishops, I nonetheless wish to address this need immediately for the Archdiocese of Boston.

Lenten Letter: Summit to protect children and minors was powerful

To that end I have decided to implement EthicsPoint, a confidential, anonymous and third-party system, exclusively for the reporting of misconduct by a Cardinal, Bishop or Auxiliary Bishop of the Archdiocese of Boston. Since 2011 we have utilized EthicsPoint for concerns of potential ethics violations, financial improprieties, and other violations of the Archdiocesan Code of Conduct related to financial matters.

Like the existing system currently in use, this will be web based and have a toll-free hotline to make a report. Reports will be sent to members of my Independent Review Board who will be charged to immediately notify law enforcement for claims of abuse as well as the apostolic nuncio; the diplomatic representative to the U.S. of the Holy

See. The system will be hosted on secured servers at the EthicsPoint facility and is not connected to the Archdiocese of Boston website, intranet system or the existing EthicsPoint system currently in use. We anticipate the system being up and running soon and will provide more information at that time.

In January 2002 the clergy sexual abuse crisis was revealed by the media in powerful and compelling reports on the failures of the Church to protect children. Courageous survivors came forward and forced the Church to face the crisis and accept responsibility for the crimes committed against them. That same year the American Bishops implemented the Dallas Charter of Norms. Where it has been faithfully implemented, it has been effective. But we must aggressively build on the Charter to ensure that there

are clear paths for reporting annually for bishops, priests, misdeeds of the hierarchy by utilizing the expertise of independent lay professionals.

During the meeting in Rome, the most powerful moments were when survivors of abuse spoke to us. This confirmed my own experience. The way forward for the Church is to hold as a priority the voices and experience of survivors, to keep them close to every step we take and make all possible efforts to provide the means for them to be heard. In Boston we will continue to provide pastoral care and counseling for survivors. We will continue to carry out programs of prevention and education in our schools and parishes. We will continue to do background checks all archdiocesan personnel, and all volunteers who work with children and young people. You may find the depth and breadth of those efforts in the Archdiocese of Boston on our dedicated website at Commitment.BostonCatholic.org.

For more than 26 years my ministry has involved responding to the abuse of minors by clergy. The crisis of sexual abuse by clergy is the greatest failure of the Church in my lifetime. It has eroded our moral authority, it endangers our pastoral, social and educational ministry, but worst of all, it devastates children and families.

We must face our past with transparency. Those who were sexually abused by clergy,

their families and loved ones must always be the central focus of our response to the crisis. Their courage in coming forward has forced the Church to face the crimes committed against them. We are committed to accompanying them on their journey toward healing. Often it is survivors who teach us not to lose hope.

As we strive to live this season with renewed seriousness and commitment we pray and work for renewal in the life of the Church. We are firmly committed to zero tolerance, transparency and accountability, at all times holding survivors as the priority, always being vigilant to do all possible to prevent any harm to children.

program returns to the streets of Chelsea this spring, riders might notice a little extra oomph in their ride.

Chelsea took part in a program with Lime Bike, along with 16 neighboring communities, last year. Council President Damali Vidot said the bike rentals will be up and running again this year.

However, there will be a difference this year, as Lime is unveiling electric-assisted bicycles throughout the region.

Because electric bicycles are currently not allowed in Chelsea, Vidot has introduced an ordinance to the City Council that would allow for the vehicles as long as they do not travel faster than 15 miles per hour.

"Since the late Summer of 2017, the City of Chelsea has been experimenting with dockless bikes, initially as a pilot with the company Ofo and then, last year, as part of a regional Metropolitan Area Planning Council (MAPC) contract with Lime Bike," City Manager Tom Ambrosino stated in a letter to the Council. "Notwithstanding some minor complaints, I believe the experiment has been successful."

"The City would like to continue this dockless bike program in 2019," stated Ambrosino. "However, there has been a change in the marketplace for dockless bikes. All the companies in this arena are moving away from pedal powered bikes to electric assisted bikes, including Lime Bike.

To continue with the regional effort with Lime and allow the bikes in Chelsea, the City will have to change the current ordinance that prohibits the vehicles.

"Over the past month, we have explored the options of replacing Lime Bike with another company that might offer dockless pedal only bikes, but no operator is interested in the restriction," Ambrosino

While the change in the ordinance would allow for the electric-assisted bicycles, Ambrosino said there are no plans in the works to allow for electric scooters to operate on public streets.

"I am just alerting the Council that the use of such scooters may soon become ubiquitous in surrounding

Councillor-At-Large Roy Avellaneda said he's looking forward to the transportation

"I'm looking forward to them," he said. "I took a practice ride, and it was quite fun."

•In other transportation-related news, Ambrosino told the City Council it should keep the future appearance of autonomous vehicles in the back of its mind.

"Right now, testing of such vehicles is underway in Boston and other communities," he said.

As with the electric-assisted bicycles, the Council would have to adjust its ordinances to allow for autonomous, self-driving vehicles. A MassDOT and MAPC agreement could allow for a pilot route for the vehicles in the Industrial District.

"It is likely to be some time before autonomous vehicles actually appear on this pilot route," Ambrosino said. "Again, such testing cannot occur until the City has given express permission. However, I just wanted to give the Council notice that this transportation innovation is moving forward and may someday make its way to Chelsea."



## **NEWS FROM AROUND** THE REGION

#### **OFFICIALS LOOK TO REVAMP CENTRAL** AVE., PARKS

EVERETT - The City is seeking input from residents on a proposal to renovate and revamp two parks up the hill from Ferry Street - with one of them proposed to be a colossal dog park.

The City unveiled plans from Bohler Engineering on Monday at a public meeting cut thin by the snow storm, and the plans call for new concepts at the Central Avenue playground and the Hale School Site on Glendale Street. Both are just around the corner from one another, and City Planner Tony Sousa said they are being viewed as tandem projects.

Both parks are in a heavily and dense residential district on the west side of Broadway, and are funded within the current Capital Improvement Plan (CIP).

Central Avenue appears to be the most exciting of the two proposals, with a plan to convert the playground into a \$1.1 million dog park.

"Central Avenue is a small parcel and our proposal is to convert it into a dog park with some public gathering space," he said. "It's designed to be an active dog park with water features and other elements. It goes beyond the traditional stone dust and grass. We're putting in a small water splash feature and misting stations with obstacles and equipment. It's no different than a traditional playground, but it is centered on dogs. It's not the first dog park, but it's the first one we're taking to this level with added amenities like a water feature and obstacle courses for dogs. It's excit-

ing.' Then, just around the corner on Glendale Street, the old Hale School site that is now a passive park would be converted to passive and active. The paths and benches would be retained, but new playgrounds would be added throughout the existing park.

"We do plan on putting playgrounds throughout the park space, and we're also potentially going to make space there for a community garden," he said.

That project is at a budget of \$1.5 million and all of the play areas would have a rubberized surface and would be ADA compliant.

Naturally, both parks would retain as many existing trees as possible, and new trees would be added along with new landscaping.

Sousa said they hope to bid out both projects as one tandem project in the spring.

"The game plan for these is to put it out to bid later this year an start construction late this fall with a completion in the spring of 2020," he said. Ideally, he said, they would

hope that one construction firm would big on both parks in order to reduce some of the mobilization costs - especially since they are only about a block from one another. This would be the first two

park projects in central Everett designed by Bohler. However, the company is not new to Everett. They are responsible for the design of the new Encore-funded playground at 7-acre Park – a playground that will be completed by

•Another park project on the way this summer is Rossetti Park by Waters Avenue and the Northern Strand Bike Trail. Already, the roller hockey rink has been taken down there, with plans for it to be moved to the seven-acre Park area. Sousa said they have \$1.1 million set aside to re-furbish the tennis courts and landscaping there.

Beyond that, and maybe more exciting, is the City is looking to locate shipping container retail opportunities on the area of the park nearest the bike path. That is an initiative championed by Mayor Carlo DeMaria earlier this year, and Sousa said they have taken his idea and hope to implement it at Rossetti.

"The electricity is already

there for the tennis courts, and we're looking to get all of that together," he said. "That's a very exciting aspect of this project."

•Other Park projects in the queue: Phase 2 of Meadows Park (behind St. Anthony's Church) will go out to bid later this month. Appleton Street Park renovations will also be bid out this spring, and upgrades to Wehrner Park will also be bid out.

Sousa said it is a credit to the City Council working with Mayor Carlo DeMaria to fund a very active CIP for this year,



Another victim, who worked at the Administration Building in 2017 and 2018, detailed other incidents where Foresteire would allegedly call and ask explicit questions. The woman said she did not report it for fear of losing her job and not being able to provide for her children.

That victim told police she felt Foresteire was allegedly obsessed with her, leading her to enlist friends and other victims to help her so she would not be alone in the building.

"The victim told me that Foresteire was allegedly obsessed with her and that he would allegedly often touch her," read the report. "She told me that he has on countless occasions allegedly put his hand on her and allegedly grabbed her butt. She stated that he would allegedly parade her around the School Administration Building as if to show her off. When he saw her, he would allegedly make her stand up and turn around so that he could look at her and inspect what she was wearing.'

That victim also detailed two alleged incidents, one in 2017 and one in 2018, when

Foresteire allegedly ripped her shirt and bra off with force, and allegedly began to kiss her exposed chest which she indicated terrified her. It wasn't long after that, she told police, that she began to complain and was finally terminated. Another former princi-

pal in Everett corroborated many of the accounts, and also reported another alleged account of a teacher who Foresteire allegedly tried to pull her clothes off during a visit to the school. The principal had written notes on the incident from 2011 that she had kept, and turned them over to police. The teacher had not wanted to report the matter so as not to risk her job, but she did request that the principal allegedly notify her if Foresteire was coming to the building so she could make sure she wasn't alone.

That principal also alleged she was the subject of a lewd comment, allegedly, by Foresteire. She alleged that after attending a School Committee meeting, the next day Foresteire called to tell her he liked to look up her dress when she sat in the front row of the meetings.

"(The principal) told me that Foresteire allegedly would 'accidentally' rub against or touch her breasts," read the report. "She told me that if she reacted, Foresteire would allegedly apologize as if it was unintentional, but if she didn't react, he would say nothing.'

To counter all of the allegations, a current high-ranking female official in the School Administration – the former director of curriculum according to the report – told police she has never heard anyone tell her of any harassment or assault by Foresteire.

"She told me that no one ever told her about Mr. Foresteire acting inappropriately," the report read. "She told me that she was the director of curriculum and that it was not her position, that any reports would go to the Title 9 director. I then asked her specifically if she recalled speaking with either (Victim 1) or (Victim 2) about Mr. Foresteire and she told me no."

Several more incidents were detailed in the criminal complaint, which are just allegations. It has been pointed out by DA Marian Ryan consistently that Foresteire is innocent until proven guilty.

In the report, Attorney Mark Rotondo is mentioned as representing some of the victims. Contacted by the Independent, he said he would

not comment on the specifics. "This cannot be tried in the news," he said. "Even Fred Foresteire is entitled to due process of law. It will be up to a jury of his peers to determine if he is guilty beyond a

reasonable doubt.' Attorney Tara Swartz has been handling cases for three victims who have filed complaints with the Massachusetts Commission Against Discrimination (MCAD). She is also mentioned in the complaint, and issued a statement last week.

"My firm represents three women who filed sexual harassment claims with the MCAD against the former Superintendent of the Everett Public Schools, Frederick Foresteire," she wrote. "My clients have always believed that they are not alone in what they endured during their employment with EPS. They remain resolute in the pursuit of their claims, as well as their hope that coming forward will assist in effectuating real change within the school system. We have no comment about the criminal charges announced today against Mr. Foresteire. We will let due process unfold and the evidence to be presented for a jury to decide.

The Everett Teachers As-

sociation said they were disturbed by the charges and said they would support their members who have been victimized.

"These are very disturbing charges," wrote President Kim Auger. "The Everett Teachers Association has taken important steps to support any members who may have been victimized and we will continue to do so.'

Foresteire's attorneys, Spruce Law, have not returned repeated phone calls to comment on the allegations.

Foresteire is due in Malden District Court on April 4 for an arraignment on seven charges.

#### APAC'S EITC PROGRAM IN FULL **SWING**

EAST BOSTON - Most people don't want to think about it, but it's the time of year to begin thinking about filing their 2018 tax returns. For many working people in East Boston there's some relief from the confusing process of figuring out taxes.

East Boston APAC, in partnership with the City of Boston, kicked off its annual Volunteer Income Tax Assistance (VITA) and Earned Income Tax Credit (EITC) program at

its office on Meridian Street. The office will be opened Monday through Friday from 9 a.m. to 5 p.m. to help begin the tax filing process. Taxes for qualifying residents can be done through appointment by calling the APAC office at (617) 567-8857.

For many working people in Eastie the program has provided some relief from the confusing process of figuring out taxes. Qualified hard working low-wage workers often receive significant EITC credits and see a big increase in their tax returns through the free program. This is money that can directly help low-income residents who work hard for their money. It can be used to pay the heat, food and rent costs that are weighing people down.

Last year, APAC returned over \$1 million back into the pockets of Eastie residents through the EITC program. APAC was one of several free tax preparation sites in the city that made filing taxes trouble-free for hundreds of Eastie's low-income residents and families.

The EITC credit can be accessed retroactively for the past three years, so qualifying low-income workers may

## Baker-Polito administration announces Greening the Gateway Cities Planting Season in Chelsea

The Baker-Polito Administration this week encouraged residents and business owners within the City of Chelsea to participate in the Greening the Gateway Cities Program (GGCP) during the upcoming spring planting season, which will commence on April 16 through June 28 (the fall planting season will be from September 2 through November 16).

As a participant, trees are provided free of charge and are planted by Department of Conservation and Recreation (DCR) work crews in an effort to reduce energy use in urban neighborhoods by lowering heating and cooling costs.

"By increasing the tree canopy within urban communities, the Baker-Polito Administration is able to improve air quality, reduce energy consumption, and further beautify neighborhoods," said neighborhoods to benefit DCR Commissioner Leo Roy. "The Department of Conservation and Recreation is pleased to have strong local partners who have worked closely with the agency to implement successful initiatives like the Greening the Gateway Cities Program.'

The Greening the Gateway Cities Program aims to plant 520 more trees in the City of Chelsea in addition to the 1,880 trees that have already been planted within the community. Since 2014, more than 19,000 trees have been planted by the GGCP in several Gateway Cities throughout the Commonwealth. The program specifically targets areas with a lower tree canopy, older housing stock, higher wind speeds, and larger renter populations. In addition,

those most in need. Within planting areas, temperature, energy use, and other information is tracked to document the energy savings new trees provide to residents over time. Pilot cities in which this monitoring is taking place include Chelsea, Fall River, and Holyoke.

Trees in close proximity to a home shade structures and lower surface temperatures. Trees up to 1,500 feet away from a home also provide important benefits to the community, such as clean air, increase in property values, reduction in noise pollution, and the creation of habitats for wildlife. Additionally, in the winter months, tree trunks and branches help to randomize wind patterns and decrease heat loss by air infiltration in poorly insulated homes. Furthermore, GGCP tree

plantings benefit the local economy through the purchasing of trees at local nurseries and employing local planting crews.

To be eligible, residents and property owners must agree to a two-year watering commitment to ensure the trees' survival. Easy care instructions are provided by DCR to tree recipients addressing watering, mulching, and pruning. When a potential tree recipient registers, a DCR forester will visit their home to determine the best location and species of tree for energy efficiency. Foresters also conduct year-round site visits and are available to answer questions.
