Preliminary election sees races in Districts 4 and 7

Polls will be open for Districts 4 and 7 from 7 a.m. to 8 p.m. for the municipal preliminary election on Tuesday, Sept. 26.

The preliminary election is for District Four for City Council and District Seven for School Committee only.

In District Four, current Councilor Tanairi Garcia is running alongside current Licensing Commission Chair Marnie MacAlpine and Adriel Adonis Rodriguez.

Due to redistricting, Garcia is not technically a candidate for reelection, since she currently represents District 7. Longtime current District 4 Councilor Enio Lopez is not running for reelection this year.

Garcia said she is a proud community activist, owner of Aloe Natural Coffee Shop, and mother

of two children.

My experience working in Chelsea is focused on Youth Development. Environmental and Food Justice, Housing Insecurity and advocating for the needs of the community as a whole," Garcia said. "My activism began at the age of 5, where I held my first sign in Cary Square. Now, thirty plus years later, I am holding my very own campaign sign for re-election. At 14 years old, I was a part of the creation of Chelsea's first-ever community garden."

MacAlpine stated that one of her largest goals is to improve communication between the residents and the city. She said she constantly hears complaints that residents don't feel heard and aren't receiving follow-up when they reach out for assistance. In addition, during

Council could select new City Manager in early October

vote on selecting a new City Manager as soon as Monday, Oct. 2. The Council was expected to receive the names of the finalists for the position from the City Manager Screening Committee at a special meeting on Wednesday evening. From there, the council has scheduled a full day of interviews with the finalists on Saturday, Sept. 30, beginning at 10 a.m. in the City Council chambers at City Hall. There will be an opportunity for public feedback on the finalists, both during the public interview sessions on Sept. 30, and prior to the full council meeting on Oct. 2, according to Councilor-at-Large Brian Hatleberg.

At Monday night's regular City Council meeting, The City Council could Hatleberg amended a motion calling for a special meeting prior to the council voting to hire a new city manager to allow an opportunity for public input.

Council looking for answers on youth football

City Councilors discussed the recent troubles surrounding the Chelsea Pride Football and Cheer team at its Monday night meeting.

public During the speaking portion of the Sept. 11 council meeting,



several parents informed the council that the Chelsea Pride team had been removed from the Northeast Commonwealth Youth Football and Cheer league prior to the first game due to allegations that the team had falsified medical records of some team members.

Inquiries to the Northeast Commonwealth Youth Football league were not answered.

Since that Sept. 11 meeting, members of the Chelsea Pride leadership met with some parents and refunded some of the league fees they had already paid, according Councilor-at-Large to Damali Vidot.

According to Council President Leo Robinson and several other councilors present at the meeting, it was announced that Chelsea Pride members could participate in the New England Flag Football League once a week. Robinson noted that the Northeast Commonwealth Youth Football League would also allow Chelsea athletes to play on teams in surrounding communities.

Robinson also noted that there will be a reorganization of the Chelsea Pride leadership and board to address issues heading into next season.

Still, the issues surrounding Chelsea Pride and the city's sometimes bumpy history with youth sports concerned several councilors who wanted to look at ways the city can help prevent future issues and ensure credible and well-run sports organizations for the city's youth.

"I think we keep brushing over the fact that they falsified medical records, because I think to me, that is the biggest thing," said Vidot.

Vidot said it is incumbent upon the city to hold the sports organizations accountable for their actions, whether through having a bigger hand in the leagues or demand-

Hatleberg said that during an earlier subcommittee meeting on Monday, the council hashed out a new plan which would allow for public input while also allowing a speedy vote on hiring a new city manager.

"This order is largely unnecessary," said Hatleberg. "We just sorted out the idea that we will add public feedback to the agenda of our meeting on the 30th."

Councilor-at-Large Damali Vidot said anyone



Public health warning issued related to recent sewage discharge

The following is a public health warning related to a recent sewage discharge, also known as a combined sewer overflow CSO). State regulations require local public health departments to provide notice to the public when these discharges may create a risk to public health, including when a discharge lasts for more than two hours.

Massachusetts Water Resources Authority Outflow MWR203, located at Prison Point in Charlestown near the Charles River Dam, experienced a discharge or overflow starting on Monday, September 18 at 2:45pm, creating a potential public health risk. The overflow ended Monday, September 18th at 11:08pm, and this advisory will expire 48 hours after the overflow has ended. Note that this data is preliminary and may be

revised. Check the Massachusetts Water Resources Authority website and the Boston Water and Sewer Commission for current updates. This event impacts the waters of the Upper Inner Harbor and Charlestown.

Boston Water and Sewer Commission Outflow BOS070, located in the Fort Point Channel, experienced a discharge or overflow starting on Monday, September 18th at 8:15pm, creating a potential public health risk. The overflow ended Monday, September 18th at 10:30pm, and this advisory will expire 48 hours after the overflow has ended. Note that this data is preliminary and may be revised. Check the Massachusetts Water Resources Authority website and the Boston Water and Sewer Commission for current updates. This event

impacts the waters of the Upper Inner Harbor and Charlestown.

The public is advised to avoid contact with affected water bodies for at least 48 hours after a sewage discharge or overflow, during rainstorms, and for 48 hours after rainstorms end, due to increased health risks from bacteria or other pollutants associated with urban stormwater runoff and discharges of untreated or partially treated wastewater.

A combined sewer overflow occurs when a large storm overwhelms the combined sewerage system causing rainwater to mix with wastewater and discharge to a nearby water body. This prevents sewage backups into homes and businesses.

ing more paperwork from teams that operate in the city.

"I'm tired of people taking advantage of our young people," said Vidot, adding that she was looking for the council to hold a meeting with the leadership of Chelsea Pride to discuss the issues.

District 8 Councilor Calvin Brown also said the city needs to take some steps to make sure organizations such as youth sports are in good standing with their leagues and with the city.

District 4 Councilor Todd Taylor noted that Chelsea Pride is an independent organization and not under the supervision of the city.

"We can't go in and tell a nonprofit how to run their business or what they do or hold them accountable in a certain way," said Taylor, although he added the city does have some oversight if the team uses city funds. "The whole situation is unfortunate, and my main concern out of all of this is basically that kids in Chelsea have an option to play football here. Whatever happened with Pride, so be it, they did what they did and now they are in the situation they are in; that has nothing to do with us."

Taylor said the city's responsibility now is to make sure there is an option going forward for the kids.

"We need some sort of option, so if the city needs to get involved or use our leadership to try to facilitate something going forward, I'm all in for that and I'll try to make that happen," said Taylor.

District 3 Councilor Norieliz DeJesus noted that the kids in the city need outlets like youth sports, and that many parents are not able to get as

involved as they want to because they have to work multiple jobs.

"I worry the most right now about the kids in the league and how can we as a council really move things quickly to secure that whatever these coaches are doing, that the kids still have something productive to do this season," DeJesus said.

District 7 Councilor Tanairi Garcia said she was at the Chelsea Pride meeting last week. She said while the meeting was uncomfortable, she was happy that the kids at least have the opportunity to take part in the flag football league.

District 6 Councilor Giovanni Recupero noted that while Chelsea Pride is currently out of commission, there is Pop Warner football once again active in the community.

DJ Workshop Project launched in partnership with Youth Elemento

On Friday, September 15th in the music room at Youth Elemento, seven young adults opened up their laptops and took part in the first of the four-part DJ Workshop Project.

The DJ Workshop Project was created by Devra Sari Zabot/Clark Ave Productions, a Chelsea based entity, and King ILabash/ King Productions.

The innovative project was funded by The Community Fund, a grant program managed by La Colaborativa. Clark Ave Productions and King Productions partnered with Wendy Mancia, Program Manager at Youth Elemento, to facilitate the program.

The Chelsea-based youth organization located in Downtown Chelsea, provides educational, social and creative opportunities for youth between

the ages of 16 and 24 and seemed like the best partner for the Workshop.

Chelsea Walk Pub sees hours cut as it plans reopening

The Licensing Commission voted to roll back the hours of the Chelsea Walk Pub due to a May violation of the city's video surveillance policy.

At last week's meeting, the commission also approved a new manager for the Broadway bar, as its current owner is seeking to sell it within the next several months.

The Chelsea Walk Pub has been closed since June as it awaited a disciplinary hearing with the Licensing Commission.

It will now be able to reopen once the police department signs off on it having a working video surveillance system.

When the pub does reopen, it will be required to close at 11 p.m. seven days per week. Most recently, the pub was open until 1 a.m. on Fridays and Saturdays, and to midnight during the rest of the week.

The disciplinary hearing stemmed from an incident in early May, when the police department requested video surveillance footage from the bar to investigate an incident that happened outside near the Broadway address.

According to Jeff Turco, the attorney representing the Chelsea Walk Pub, employees were unable to access the video surveillance footage and the password for the system was not working.

Under Chelsea ordinances, liquor establishments must have a working video surveillance system that stores 30 days of video.

"The bottom line is they could not figure out why the PIN password they had was not working,' said Turco.

electronics A local company also reviewed the system and could not access the footage.

Turco noted that at the request of the Licensing Commission, the Chelsea Walk Pub has been closed since June.

The overall plan for the Chelsea Walk Pub is to reopen with a new manager and a working video surveillance system while the current owner works out details for a sale of the bar.

Licencing Commission Chair Marnie MacAlpine noted that while the Chelsea Walk Pub closed in the middle of June, it did operate for the better part of a month without a working video surveillance system.

"I would expect a responsible owner to make every effort to fix that so they could be in compliance," said MacAlpine.

Commission members questioned why the pub was going through a change of manager when the owner expects to sell within the next several months.

Turco replied that the current owner, Angela Palmieri, has some health issues and is not able to be on site for the required hours. He also noted that she wants the pub to reopen to show that it is a viable business for potential new owners.

The commission approved the change in ownership, but voted to roll back the hours of operation due to the violation of the surveillance ordinance.

"You have been before the commission before on disciplinary (issues), and you know how important the video is," said MacAlpine. "I'm a little bothered by the fact that there was no good faith effort to contact someone and try to get it repaired prior to June."

In other business, the Licensing Commission approved a change of hours for the amusement and entertainment license for Las Vegas Restaurant at 388 Broadway. The later entertainment hours are in line with the extended closing hours approved by the commission earlier this year.

The commission also approved an RFP for an on-premises, all-alcohol license for Preciado Brothers, LLC, doing business as P'onde Juancho at 400-406 Broadway.

Officials raise risk for EEE to high in three more communities

The Massachusetts Department of Public Health (DPH) last week announced that Eastern equine encephalitis (EEE) has been detected in an additional mosquito sample collected on September 13 in Brimfield. This finding raises the EEE risk level to high in Brimfield, Sturbridge, and Holland and to moderate in Wales.

This is in addition to the six communities already at high risk for EEE: Douglas, Dudley, Oxford, Southbridge, Sutton, and Webster. Auburn, Charlton, Grafton, Millbury, Northbridge, and Uxbridge are at moderate risk.

"The forecast is for cooler temperatures which will start to reduce mosquito activity," said Dr. Catherine M. Brown, State Epidemiologist. "However, the risk for spread of EEE virus from mosquitoes to people is still present. Everyone in these moderate- and high-risk areas should take the recommended steps to prevent mosquito bites; this includes avoiding outdoor activity between dusk and dawn in the high-risk communities."

EEE is a rare but serious and potentially fatal disease that can affect people of all ages. EEE is generally spread to humans through the bite of an infected mosquito. There were 12 human cases of EEE in Massachusetts in 2019 with six deaths and 5 human cases with one death in 2020. There were no human cases of EEE in Massachusetts in 2021 or 2022. No human or animal case of EEE has been detected in Massachusetts so far this year.

People have an important role to play in protecting themselves and their loved ones from illnesses caused by mosquitoes.

Avoid Mosquito Bites

Apply Insect Repellent when Outdoors. Use a repellent with an EPA-registered ingredient (DEET (N,N-diethyl-m-toluamide), permethrin, picaridin (KBR 3023), oil of lemon eucalyptus [p-Menthane-3,8-diol (PMD)] or IR3535) according to the instructions on the product label. DEET products should not be used on infants under two months of age and should be used in concentrations of 30 per-

cent or less on older children. Oil of lemon eucalyptus should not be used on children under three years of age.

Be Aware of Peak Mosquito Hours. The hours from dusk to dawn are peak biting times for many mosquitoes. Consider rescheduling outdoor activities that occur during evening or early morning in areas of high risk.

Clothing Can Help Reduce Mosquito Bites. Wearing longsleeves, long pants, and socks when outdoors will help keep mosquitoes away from your skin.

Mosquito-Proof Your Home

Drain Standing Water. Mosquitoes lay their eggs in standing water. Limit the number of places around your home for mosquitoes to breed by draining or discarding items that hold water. Check rain gutters and drains. Empty unused flowerpots and wading pools and change the water in birdbaths frequently.

Install or Repair Screens. Keep mosquitoes outside by having tightly fitting screens on all windows and doors.

Protect Your Animals

Animal owners should reduce potential mosquito breeding sites on their property by eliminating standing water from containers such as buckets, tires, and wading pools - especially after heavy rains. Water troughs provide excellent mosquito breeding habitats and should be flushed out at least once a week during the summer months to reduce mosquitoes near paddock areas. Horse owners

GET YOUR COVID-19 BOOSTER SHOTS

While we would all love to leave COVID-19 in the rearview mirror, the stark reality is that the virus is still circulating among us, with the elderly and persons with compromised immune systems the most vulnerable to becoming seriously ill and dying from the virus.

Even otherwise healthy individuals, especially if they are overweight, run the risk of becoming seriously ill from the disease in the short-term and potentially suffering the lingering and debilitating effects of long-COVID, which has been well-documented, though it remains poorly understood.

Fortunately however, the CDC has approved the updated COVID booster vaccine that has been proven to be an effective and safe preventative measure against both catching the disease in the first place and, if infected, mitigating its most harmful effects.

The reasons we need an updated booster are threefold: First, the effectiveness of the vaccine diminishes over time. Thus, the shots we received last year are significantly less protective today than they were 12 months ago. Second, the virus has mutated in the past year and the updated vaccines will provide protection against this ever-changing virus. Third, as we enter the fall and winter months, families will be gathering, with many having traveled in airplanes and returning from school, which are breeding grounds for the virus, and therefore looming as potential threats for parents and grandparents. We would note that from January to July of this year, 88 percent of deaths from COVID-19 were among people who were 65 years or older.

The Executive Office of Veterans Services (EOVS) proudly announces the revival of the Veteran's Reintegration Advisory Committee (VRAC) and the appointment of seven new committee members. VRAC is entrusted with actively investigating, studying, and scrutinizing various aspects of veterans' reintegration into civilian life. Its primary objectives include reducing suicide rates and addressing the profound effects of post-traumatic stress disorder (PTSD), depression, and anxiety among veterans. Furthermore, the committee will explore the impact of community peer liaisons on veterans' successful reintegration into society and delve into the critical link between isolation and veteran suicide.

"We remain steadfast in our commitment to veterans' well-being. The EOVS team and I are wholeheartedly dedicated to standing up this Committee, which comprises renowned leaders from the healthcare community. I eagerly anticipate the Committee's findings and recommendations," said Secretary Jon Santiago of the Executive Office of Veterans Services.

VRAC's establishment directly results from the statutory mandate outlined in S3097, the "Act addressing barriers to mental health care," enacted on August 10, 2022. The committee will comprise a diverse group of individuals, including representatives from prominent organizations such as Massachusetts General Hospital's Home Base Program, the Wounded Warriors Project, the Mass Mentoring Partnership, Inc., the Massachusetts Coalition for Suicide Prevention, the Massachusetts Psychological Association, Inc., as well as esteemed professionals and experts from various fields.

Area banks participate in nonprofit end homelessness campaign

A group of Massachusetts-based banks recently celebrated a campaign that raised awareness and \$300,000 for nonprofit Heading Home, which works to end homelessness.

During last Friday's Red Sox - Orioles game, bank representatives appeared on the Fenway Park baseball diamond to present an oversized check to Heading Home. The Boston-based nonprofit is one of the city's leading providers of emergency shelter, transitional and permanent housing for extremely low-income families and individuals experiencing homelessness.

The campaign, "Heading4Home," launched

in April 2023 with eight
banks participating at various levels all united for
the same goal.

"We are excited and proud to see community banks in Massachusetts come together in the fight homelessness," against said Northern Bank President & CEO Jim Mawn. "As community bankers, we represent a powerful force because of our collective commitment to the communities we serve. We are uniquely positioned to give back in a meaningful way. Thank you to all the banks for your participation - we cannot wait to do this again next year!"


Gabriella attended Williams School in Chel-

Passengers urged to plan ahead as detours expected at Logan

Special to the Times-Free Press

Due to ongoing roadway work that will impact passengers using Terminals B, C and E roadways, the Massachusetts Port Authority (Massport) is urging departing passengers to plan for extra time if driving to the airport and/or utilize the various transit modes to get to and from Logan. Terminals B and C are Boston Logan's busiest terminals – B serves American, United, Air Canada, Spirit, Southwest, Boutique and Alaska, while C serves JetBlue, Aer Lingus, Cape Air and TAP Air Portugal. Ongoing roadway construction will revamp the current terminal roadway system to eliminate backups, enhance the passenger pickup and drop off process, and get passengers to and from the terminals faster, improving the overall customer experience at Boston Logan. During the 11-day period through September 25 (weather permitting), the roadway construction will require detours. Terminals C and E Departures traffic will be detoured to alternative roadways. Terminal C Departures level traffic will be re-routed to the Arrivals level roadway to the Terminal C Ride App area in Central Parking. Terminal E Departures level traffic will be detoured through Terminal B Departures. For one day on September 16, Terminal C and E Arrivals traffic will be detoured through Terminal B Arrivals. Additional signage is being installed and State Police and Massport Ground Transportation staff will be on site to assist drivers. The roadway construction is replacing the aging roadway infrastructure along both levels between the terminals. When work is completed, Terminals C and E Departures traffic will be able to use the newly constructed roadway and will no longer have to merge with vehicles exiting Terminal B. The construction will also create more curb space at Terminal C – and reduce congestion on Boston Logan's roadways — by improving traffic flow and increasing traffic safety. This project is set to be completed this November. We strongly urge pas-

sengers to take advantage of the various transit modes to and from Logan, such as MBTA's Silver Line (FREE from Logan), Blue Line and water ferry, Logan Express, and private bus lines. Massport operates four suburban Logan Express services including Framingham, Braintree, Woburn and most recently Peabody at

Area groups form Plastic Free Mass

Over a dozen community and environmental groups have joined forces to form Plastic Free Mass, a new coalition dedicated to ending the use of polluting plastic. The group will push for new policies to protect our Commonwealth's residents and natural resources by ending our plastic addiction and moving us toward a cleaner future.

The data couldn't be clearer. Nearly 40% of the plastic produced annually is for single-use plastics and packaging. Very little plastic – between 5-6% in the United States – is actually recycled. Plastic is toxic and polluting at every stage of its lifecycle – from extraction and manufacturing, to use, recycling, and disposal. Many single-use plastics can be easily reduced, redesigned for reuse, or replaced with nontoxic alternatives.

"The Friends of the Malden River have sponsored many cleanups around and in the Malden River. The Malden River, a typical urban river, is inundated with plastic pollution due to its physical connection with the city's stormwater system. Volunteers have removed thousands of single use plastic items and pounds of degraded polystyrene from the waterway. It is distressing. We have witnessed the contamination of the collected recycling at our local single stream recycling system. Typically, over 65% of Malden's collected recyclables are contaminated with plastic bags, household waste, and nonrecyclable plastics and metals. This contaminated recycling is incinerated at the Wheelabrator Saugus Plant. The Plastic Blight needs to end with

state legislation and public awareness, " said Karen Buck, Friends of Malden River.

Accordingly, we support legislation, policies, and programs that: phase out and avoid the production and use of any unnecessary single-use plastics, reduce and eliminate plastic packaging whenever possible, and modernize our state's beverage container deposit system to include reuse and refill targets.

The members of Plastic Free Mass include Berkshire Environmental Action Team, Berkshire Zero Waste Initiative, Beyond Plastics, Clean Water Action, Conservation Law Foundation, Container Recycling Institute, Environmental League of Massachusetts, Friends of the Malden River, Just Zero, Metropolitan Area Planning Council, MetroWest

Climate Solutions, Mothers Out Front, Oceana, Progressive Democrats of Massachusetts, Seaside Sustainability, Slingshot, and Story of Stuff.

"The Commonwealth of Massachusetts is an environmental leader in so many ways, so it's particularly disappointing to see us fall behind in the area of solid waste. For example, our state is one of the only states in New England without a statewide plastic bag ban, and our bottle bill has one of the lowest redemption rates in the country. We must move quickly and decisively to remedy these shortcomings or we risk falling even further behind in the fight to curb the climate crisis, " said Kirstie Pecci, Executive Director, Just Zero

chusetts Governor Maura Healey announced a plan to ban state agencies from buying single-use plastic bottles. Conservation Law Foundation (CLF) released the following statement in response.

"Single-use plastics are a scourge on our environment and our communities," said CLF zero waste attorney Mara Shulman. "These products hasten the climate crisis and endanger the health of people and wildlife. Governor Healey's ban is a great step towards making Massachusetts a leader in fighting the plastics crisis."

CLF and our partners in the Plastic Free Mass coalition and Zero Waste Caucus are pushing for the legislature to ban all sorts of single-use plastic, modernize the state's antiquated beverage container deposit system, and pass an extended producer responsibility for plastic packaging law.

"It's time to finally address the plastics crisis in Massachusetts. From modernizing our antiquated beverage container deposit system, to banning single-use plastic bags at checkout, to making producers of plastic packaging responsible for reducing packaging and managing plastic waste at its end of life, there are several pending bills that will take us in the right direction. We stand with our elected officials and pledge to keep up the momentum because there is no time to waste in taking a bite out of waste."

Settling in with pets

When you move with pets, you have the added task of finding new VIPs for your furry friends those who walk dogs, care for your pets when you travel, groom your critters, and provide routine and emergency veterinary care. In addition, you need to obtain the local licenses your municipality requires and update your contact on the microchips and tags identifying your animals.

Recommendations

Fortunately, the Greater Boston Area has many pet-friendly hotels. Finding a place for your sister and her dog to stay (if your building does not allow pets) should be easy.

Finding someone to groom, pet sit, or dog walk during the holidays is more complex. If you have a regular service, ask about boarding, sitting, or if you will have a visiting dog to walk over the holidays. As much as they'd like to accommodate regular customers, there's a limit to how many animals a pet sitter can accept.

should keep horses in indoor stalls at night to reduce their risk of exposure to mosquitoes. Owners should also speak with their veterinarian about mosquito repellents approved for use in animals and vaccinations to prevent WNV and EEE. If an animal is suspected of having WNV or EEE, owners are required to report to the Department of Agricultural Resources, Division of Animal

Health by calling 617-626-1795, and to the Department of Public Health by calling 617-983-6800.
